Free Income Tax Filing Help!

Make sure you claim all eligible tax credits!

You may be eligible for no-cost tax preparation help that could mean a bigger refund on your 2015 tax return!

Who is ELIGIBLE for the Earned Income Tax Credit?

SINGLE, HEAD OF HOUSEHOLD, WIDOWED	EARNED INCOME AND ADJUSTED GROSS INCOME MUST BE LESS THAN:	MAXIMUM CREDIT
No qualifying children	\$14,820	\$503
One qualifying child	\$39,131	\$3,359
Two qualifying children	\$44,454	\$5,548
Three or more qualifying children	\$47,747	\$6,242

MARRIED, FILING JOINTLY	EARNED INCOME AND ADJUSTED GROSS INCOME MUST BE LESS THAN:	MAXIMUM CREDIT
No qualifying children	\$20,330	\$503
One qualifying child	\$44,651	\$3,359
Two qualifying children	\$49,974	\$5,548
Three or more qualifying children	\$53,267	\$6,242

Investment income must be **\$3,400** or less for the year.

- Social Security cards, Tax ID or ITIN for anyone on the return, including children, spouse and other dependents
- W-2's, 1099's & 1095 A/B/C
- Copy of your 2014 Tax Return (if available)
- Valid government photo ID

ALSO:

- For child and dependent care credits, bring the Tax Identification Number of the child care provider
- For Direct Deposit, bring a checking or savings account number with the routing number
- Any statements received from a mortgage company during 2015
