- 1. **Call to Order** at 7:03 P.M.

- **5. Approval of Minutes** January 17, 2019 Meeting Minutes to be presented at next month's meeting.
- 6. Old Business
 - a. Master Plan the report is almost completed, and the links should be added shortly.
 - b. Haselton Barn Roof Update the roofing project had been presented to the Board of Selectmen on Feb. 12, 2019. \$5,800 will be appropriated for an engineer study as a starting point to determine if the structure will support a new roof. An inspection with an engineering firm will be performed this coming week. The roofing project will need approval from DHR. The Town will contact the State if we are unable to comply with recommended specifications outlined in the deed.
 - c. Kitchen Roof Update The tiles have been sent out for testing. The results should arrive in 1 to 2 weeks.

- a. Discussion of Trail Conditions the markers on the trails should be inspected and replaced as necessary.
- b. Kitchen Windows the plywood covering the windows appears to be rotting. It was suggested that the glass on the windows could be replaced and leave the plywood on the inside of the building.
- c. Cardboard Sled Race has been indefinitely postponed again. If snow arrives, there could be a possibility for rescheduling the event.
