## 5. Approval of Minutes

### 6. Old Business

a. Haselton Barn Roof Engineer's Report: This report confirmed that the structure will support a new roof, with some stipulations: one rafter has to be replaced; put up scaffolding on the building.

- b. Kitchen Roof update: Cost estimate to replace the clay tiles is \$70,000. This has been put in the Capital Plan.
- c. Restroom update: The masonry walls and door frames are installed. Next, the ceiling tiles will be installed Friday or Monday. The restroom may be ready for Memorial Day weekend.
- d. Volunteer Day Planning: Volunteer clean up day 9 am to 2 pm this Saturday, April 20. Will have a meal for the volunteers. Will start working around the slide and the waterway. Will plan to cut back some of the bittersweet before it damages the trees. There is a piece of culvert behind Post #17 that they hope to get installed.

### 7. New Business

- a. 2019 Project Planning:
  - i. Need to get some wood and stain to replace some of the picnic tables' boards soon. Want to get the boards cut and stained before the May cleanup, so the new boards can be installed then.
  - ii. Need to repaint the exterior of the Shoe, not just the toe.
  - iii. Want to install two new Maples by the playground. Dick will talk with the vendor.
  - iv. Possible project: Storybook Hill
  - v. Possible project: Painting (weather dependent), including office building.
- b. Liberty Utilities: Working on a volunteer plan. Date is not yet set, but it will be during the week. Dick will email the dates when set.
