# 1. Call to Order

## 5. Old Business

## A. Use of Forms for Park Usage Park Events

The Board of Selectmen had asked for reasons why the committee had felt the need to use the Benson Park Usage Forms. After much discussion the committee determined that the forms keep us informed about large numbers of visitors via registering with the Recreation Department and the need for someone to monitor the Porta-Potties' situation. The Highway Department also uses this information to schedule the maintenance days at the park. The committee recommended the continued usage of the forms.

The committee has recommended that we do not establish fees for large groups visiting the park. After much discussion members concluded that the collection of fees should be deferred at this time until we arrived at documented expenses and the interpretation for the definition of "a group." Further discussion revolved around the topics of clarification on the park usage form and better communication for events scheduled at the park.

### **B.** Resolution of Park Spot Reservation

Desired spots for an event at Benson Park cannot be guaranteed. Rather than make a reservation, a notation for a requested area on the park usage form would be more suitable. A location for an event would operate on a "first come, first serve" basis since it would be impossible to enforce a reservation or request. The Benson Park Usage Forms and Calendar would be organizational tools for activities within the park.

#### C. Budget Concerns for 2017 - Porta-Potties

The Board of Selectmen has recommended that Porta-Potties be maintained on a regular basis and serviced as dictated by the visiting guests. The budget for 2017 has increased funds for the maintenance of the Porta-Potties.

# 6. New Business.

#### A. Liability Waiver Forms

The decision was made to have a Liability Waiver Form which would cover a 3 year period and expire on the same date for everyone at the end of the cycle. These forms would be housed in the Office. (The older forms from previous years will be archived 4 years after they expire.)

#### **B.** Amphitheater Issues

The town will grade and seed the areas around the newly erected Mallory Gray Amphitheater (which was installed on Dec. 13, 2014.) Some committee members felt that shrubs and flowers should not be planted nearby the structure so that the Highway Department will be able to maintain their mowing schedule. The Landscape Sub-committee would like to view the landscaping plans with the Mal's Pals organization and address maintenance concerns. More information will be forthcoming as our committee awaits the future date of the ribbon cutting ceremony for the Amphitheater.

# 7. Other Business/Remarks by Committee Members

J. Leone announced that the Friends of Benson Park are making preparations for the 5<sup>th</sup> year celebration of Benson Park around the first weekend of June. J. Leone discussed some of the ideas for the celebration such as an Old Fashion Picnic, three legged-races, refreshments, publicity, and attracting other groups to

renew an interest in the park. Details still need to be worked out, and A. Desrosiers and H. Schibanoff have volunteered to work with the Friends for the celebration.
