Benson Park Committee Meeting Minutes Dec. 4, 2014

#### 1. Call to Order

Chair H. Schibanoff announced that he would be undergoing hip surgery after Jan. 12<sup>th</sup> and would be recovering over the next several months. He also stated that his term on the Benson Park Committee would expire in April 2015.
