Town of Hudson Benson Park Committee Meeting Minutes April 17, 2014

1. Call to Order

The regular meeting of the Benson Park Committee was called to order by Chair H. Schibanoff at 6:30pm, April 17, 2014, at the Benson Park Office Building.

6. New Business

A The Benson Park Committee conducted a <u>Walk Through Tour</u> of the park to form a list of highlighted projects which could be attempted over the next several months. D. Empey will assemble the list of proposed projects which include the location for the new gazebo with walkways at the peninsula on Swan Lake, removal of bittersweet, repairs to picnic tables, re-shingling on the A Frame roof, cleaning and weeding out areas near Serenity Garden, removal of dead and broken trees near the Chestnut Tree Area, removing old tree stumps behind the office, and regrading the area at the former Red Barn. The committee also commented on possible locations for the installation of the engraved stone near the Old Shoe.

B. Lori Bowen updated the committee with the latest developments for the Amphitheater. Ground breaking will be happening in mid-July, and the installation of the structure will be a 2 to 3 day project in August – to be performed by a skilled and competent volunteer crew.

Lori Bowen, the Coordinator for the Hudson Senior Services, also proposed activities for the seniors to utilze the park. In September she would like to implement a low-impact walking program throughout the park whereby seniors would partake in walking activities on mapped distances - including distances for a Benchwalk.

7. Other Business/Remarks by Committee Members

Committee members expressed concern for groups who have scheduled events (via permits) at the park to celebrate birthdays, weddings, reunions, picnics, etc. Most felt that it would be helpful and beneficial for the committee and visitors to know beforehand if specific <u>venues</u> had been requested – along with <u>designated times</u> for usage. While there is no policy for ensuring that a permit would be honored in the event of a conflict with another visiting group, a more a detailed permit could resolve any unforeseen issues.
