> Benson Park Committee Meeting Minutes June 20, 2013

1. Call to Order

The regular meeting of the Benson Park Committee was called to order by Chair H. Schibanoff at 7:05 p.m. June 20, 2013, at Benson Park, Kimball Hill Road.

2. Attendance:

3. Public Input

Jerry Desrosiers said he has been in the park watching the fishing Derby and children playing near the water. He understands that the committee and the Town have a focus on safety and thought a few life saving rings should be placed around the pond. He gave examples of things that could happen. He also addressed the use of grills in the park and wanted to know the policy on this. He is referring to charcoal grills, ie: where the hot charcoal should be dumped, where to place the grills, etc. P. Nichols liked the idea of the life saving rings, said it wouldn't hurt. J. Leone said he was not aware if these were placed at other parks. N. Undercofler said the rules say no swimming at the park. Small children would not be able to grab ring. Discussion followed and consensus was no life savings rings at this time. A discussion on Charcoal Grills in the park followed. Chair H. Schibanoff said he has told people that they can be used. The new rules have been posted and nothing is written about grill use in the park. D. Empey said he thought that the reunion group emptied their charcoal grill on the grass in the new picnic area. Selectman Liaison B. Nadeau said that group did not use grills. Chair H. Schibanoff asked if we should monitor this for the time being, and Selectman Liaison B. Nadeau said to do this and also speak to the Fire Chief. N. Undercofler was also thinking along those lines, especially if there were warnings around for no fires. Selectman Liaison B. Nadeau will mention this to the Fire Chief and a sign could be posted when Fire Danger is High.
