# Benson Committee Meeting Minutes June 25, 2009

#### 1. Call to Order/Roll Call

- a. The regular meeting of the Benson Committee was called to order at 7:08 pm on June 28, 2009 in the Board of Directors Room at the Town Hall with the Pledge of Allegiance. Chairman, K. Dickinson, presided

#### 3. New Business

- a. **Selectmen's Update**: Selectman, S. Jasper mentioned the roofing estimate packet that the Committee Members received prior to the meeting. He publicly thanked Assistant Town Administrator for formatting the roofing estimates and analyzing same for this committee. Selectman Jasper gave an update on the form to be put on the web site for the Management Units and C. Laffin's explanation on what these units are and what is expected from these sub committees. As of the 12<sup>th</sup> of June these forms are on line and hard copies will be available at the Benson Exhibit.
- Assistant Town Administrator, M. Pearson gave an explanation to the Television Audience on what the Committee and the Board of Selectmen will be reviewing before June 30<sup>th</sup>. On June 2<sup>nd</sup>, the Board of Selectmen asked to have an RFP developed for the Benson building repairs. Assistant Administrator M. Pearson designed an RFP to meet the needs of the roofing on the buildings on the Benson Property. Booklets containing the contractors bids were given to the Committee and the Selectmen and are listed under the letters A through K. These letters represent each contractor. The analysis of the three Historic buildings, the Office Building, Hazelton Barn and the Train Station are single bids from contractors and the analysis of the bid package for the Gorilla House, Elephant House and A-Frame have alternate bids, one for a rolled roof and one for 30 year shingles. Mr. Pearson also spoke of a broad range of prices and structure report for the Hazelton Barn. He also gave information on the Train Station roof which has monies of it's own for repairs. Selectman Jasper, H.Schibanoff and Jerry Desrosiers asked many in-depth questions that Assistant Town Administrator M. Pearson answered to the best of his ability so that the Committee could make an informed decision on the bids.
- c. Chairman K. Dickinson stated that we have bids on six buildings to review. In order to move the meeting along a 15 minute moratorium would be put on each bid for questions from the Committee members. If more time is needed an extension could be granted.

#### 4. Review of Bids/Recommendations

Chairman K. Dickinson asked for motions on contractor's bids.

#### a. Office Building:

Motion made by J. Barnes and seconded by Selectman S. Jasper to select contractor  $\underline{\mathbf{H}}$  as first choice.

All in favor No Nays. Motion Carries.

b. Pat Nichols made a motion to select contractors  $\underline{\mathbf{B}}$  &  $\underline{\mathbf{J}}$  as  $2^{nd}$  and  $3^{rd}$  choice. H. Schibanoff seconded.

An In-depth Discussion followed the motion.

All in favor No Nays. Motion Carries.

**c. Hazelton Barn:** H. Schirbanoff and J. Desrosiers rescind their first choice contractor **B**.

Selectman S. Jasper made a motion to recommend contractor  $\underline{\mathbf{H}}$  as first choice, J. Desrosiers seconded the motion.

An In-depth discussion followed.

All in favor no nays. **Motion Carries**.

Vice Chairman K. Matthews made a motion to select  $\underline{\mathbf{B}}$  &  $\underline{\mathbf{D}}$  as  $2^{\text{nd}}$  and  $3^{\text{rd}}$  choice, S. Rumbaugh seconded the motion.

In-depth discussion followed.

6 Ayes, 2 Nays. Motion carries.

d. **B&M Railroad Station**: J. Desrosiers made a motion to recommend contractor  $\underline{J}$  as first choice, and Selectman Jasper seconded the motion. In-depth discussion followed.

All in favor No Nays. Motion Carries.

Selectman Jasper made a motion to select contractors  $\underline{\mathbf{C}}$  &  $\underline{\mathbf{D}}$  as  $2^{\text{nd}}$  and  $3^{\text{rd}}$  choice, J. Barnes seconded the motions.

In-depth discussion followed.

All in favor No Nays. Motion Carries.

Chairman K. Dickinson recessed the meeting for 10 minutes at 8:35 pm

Chairman K. Dickinson called the meeting back to order at 8:45 pm

#### f. Elephant House: Keep the Elephant House:

Selectman Jasper made a motion to keep the Elephant House, Jerry Desrosiers seconded the motion.

Selectman Jasper made a motion to select contractor  $\underline{\mathbf{H}}$  as first choice. P. Nichols seconded the motion.
