• Approval of minutes:

proposed. We also discussed that the plaques need to be substantial with a writing criteria to be approved. Mr. Madden will research with some local companies general sizes and cost to review.

Chairman Empey stated the aeration system is working fine but they have not seen much results. It will take time - about 2 years to get where we want to be with the system but it is working well. He also stated we have more mulch to spread on volunteer day. Lastly, he is still working on the Storybook Walk with the library.
