

Old Business:

- A. Removal of asbestos from the Train station Jack contacted a new firm (ACM Demo) to request a bid and contacted A-Best Abatement who was the previous low bidder to see if they could refresh their bid. Both firms provided their best bid. Jack has provided both bids and the copy of the inspection from 2018 outlining the work and what needs to removed via email on Tuesday, August 16th to the Board of Selectman. A vote will take place on August 23rd to determine which firm will be selected and to approve the use of funds.
- B. Mural in the Gorilla House this mural is coming along well. Several committee members stated they had viewed the progress. Selectman Morin shared that he is concerned that the protective spray to cover the mural as previously discussed may not work with the paint. Selectman Morin said he would follow up with his contacts

- to determine if this would be an issue and let the committee know once he had an confirmation.
