- **Public Input:** Steve Przystac asked the committee for an update on the Adopt a Spot signs. He was informed that Chairman Madden was out sick this evening and he was the individual looking into the pricing. We do not have an answer for this meeting.

Phyllis Appler from the GFWC Hudson Women's Club asked if the committee would grandfather their new toolbox to be allowed on their site. She provided some history that their group was asked by the previous committee to create the Butterfly Garden and they need these tools to keep the garden maintained. The previous box was falling apart due to age. The committee stated they did not need to vote on anything as nothing different was being done. The toolbox is the same approximate dimensions therefore no vote is needed.

Sue Clement provided some updates. The piping for the water storage tanks is working for people to use for their Adopt a Spots. She also mentioned the volunteers who wanted to paint the Old Lady Shoe have started painting it. She also thanked Mike for having the additional bark mulch delivered. Sue found out that there is no electricity at the sites. Lastly, they are discussing to have maybe rocks around the Shoe to help protect it from the rain splashes from deteriorating it.
