#### Nomination of Chairman, Vice-Chairman, Clerk

Question by Mr. Morin about organization, particularly creating Clerk Alternate position. The Clerk Alternate is a backup for the Clerk if the clerk is absent for the meeting. Understands the requirements of the Clerk position. Also rises to the Clerk position if the current Clerk steps down.

Motion (Price/Morin) to nominate B. Guessferd as Vice-Chairman; passed 7-0-1 (B. Guessferd abstained)

Motion (Guessferd/Price) to nominate J. Fernald as Clerk; motion passed 7-0-1 (J. Fernald abstained)

Motion to create Clerk Alternate (Price/Fedele), motion passed unanimously.

Motion (Morin/Guessferd) to nominate L. Robicheau-Pagan as Clerk Alternate, motion passed unanimously

#### **Adoption of By-laws**

Motion (Price/Morin) to accept existing by-laws as written, motion passed unanimously

Need to add Clerk Alternate to by-laws. Chairman Trost also proposes the following amendments:

- 1. Officers Nominations of, and elections, for all officers shall be by a majority vote of those present
- 2. A Chairman, Vice-Chairman, Clerk, and Clerk Alternate shall be elected at the first regularly scheduled meeting following the Annual Town Meeting, but not later than April 30.
- 3. In the case of a vacancy in the position of Chairman after such election, the Vice-Chairman shall immediately succeed to the position of Chairman. The Clerk shall thereupon succeed to the position of Vice-Chairman.
- 4. In the case of a vacancy in the position of Vice-Chairman after such election, the Clerk shall immediately succeed to the position of Vice-Chairman.
- 5. In the case of a vacancy in the position of Clerk or Clerk Alternate after such election, an election to fill the vacant position(s) shall be held at the first regularly scheduled meeting after the position(s) become vacant.
