Patty Langlais (22 Stonewood Dr.) – Addressing the concerns and accuracy of the description that during snowstorms, School Department trucks were not used.

Mr. Morin requested (on behalf of the Board of Selectmen) town plowing expenses for the School Department. Chairman Trost stated Mr Morin's request was an extension of the original request and did not require a motion.

Selectman Luszey and Superintendent Russell discussed the following items with the Budget Committee:

- School Department budget surplus and fund transfers are still appropriating taxpayer funds, despite saying there is no tax impact
- Cost per pupil and different sources of funding (taxpayer, grants, state and federal governments)
- Declining enrollment

Chairman Trost reminded the committee we can still make motions up to the conclusion of the initial deliberations (12/27 for Town budget and 01/03 for School Department budget) and the straw vote is only the first formal vote (the final recommendation vote takes place after the public deliberation) Mr. Murray thanked the School Department for their work in preparing and presenting budgets

Ms. Hopkins questioned whether we had the most recent copy of the snow plowing contract. Resolved question – there were two attachments Mr. Guessferd suggested the possibility of centralizing mass purchasing.
