#### E. Town Budget Warrant Articles and Budget Review

Town Administrator Steve Malizia presented Warrant Article P for Committee consideration.

#### Warrant Article P:

Shall the Town of Hudson vote to approve the cost items included in the collective bargaining agreement reached between the Town of Hudson Board of Selectmen

and the Hudson Police, Fire and Town Supervisors Association which calls for the following increase in salaries and benefits:

Year	Amount	COLA%
7/1/15 - 6/30/16	\$70,335	2/0%

and to raise and appropriate the sum of \$70,335 for the 2015-2016 Fiscal Year, said sum representing the additional costs attributable to the increase in salaries and benefits over those paid in the prior Fiscal Year?

**Straw Vote:** 6 – 5, Shawn Jasper, Jonathan Maltz, Joyce Goodwin, John Drabinowicz, Randy Brownrigg opposed, the remaining members in favor.

Chairman Jasper passed the gavel to Vice-Chairman Maltz.

**Motion:** Shawn Jasper moved to reduce Town Budget line item 04-4550-5060-102-000, Library, Salaries Part Time from \$206,246 to \$191,246, a reduction of \$15,000. Motion seconded by Randy Brownrigg.

**Vote:** Motion passed 11 – 0.

The gavel was returned to Chairman Jasper.

Motion: Jonathan Maltz moved to reduce Town Budget line item 04-4550-5060-209-000, Library, Heating Oil from \$9,500 to \$6,000, a reduction of \$3,500.
 Vote: Motion passed 9 – 2, Stephen Nute and Michael Truesdell in opposition, all others in favor.

#### F. School Budget Warrant Articles and Budget Review

School Superintendent Bryan Lane presented Warrant Article 2 for Committee consideration.

#### Warrant Article 2

Shall the Hudson School District vote to approve the cost items included in the collective bargaining agreement between AFSCME Local 1906 Council 93, AFL-CIO and the Hudson School Board which calls for the following increases in salaries and benefits at the current staffing levels over the amount paid in the prior fiscal year:

2015-16	\$146,321
2016-17	\$146,252
2017-18	\$150,523

and further to raise and appropriate \$146,321 for the upcoming year, such sum representing additional costs attributable to the increase in salaries and benefits required by the agreement over those that would be paid at the current staffing levels?

Since this Warrant Article had not been provided to the Committee members prior to this meeting, there was no straw vote.
