Motion: John Drabinowicz moved to table the Town Budget in the amount of \$23,959,448. Joyce Goodwin seconded the motion.

Vote: Motion passed 9-1, Selectmen Ted Luszey opposed.

(This appropriation is in addition to Article A, the Operating Budget) (Recommended by the Board of Selectmen) Estimated tax rate impact is less than one cent

Shall the Town of Hudson vote to establish a Capital Reserve Fund under the provisions of RSA 35:1 for the purpose of improving/renovation and replacing equipment at Recreation Facilities to be known as "Recreation Equipment Capital Reserve Fund" and to raise an appropriate the sum of \$5,000 to be placed in this fund an to further appoint the Board of Selectmen as agents to expend from this fund. (Majority vote required) (This appropriation is in addition to Article A, the Operating Budget) (Recommended by the Board of Selectmen) Estimate tax rate impact is less than one cent

Should this article be defeated, the operating budget shall be \$23,329,646 which is the same as last year,

with certain adjustments required by previous action of the Town of Hudson or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X and Xvi, to take up the issue of a revised operating budget only.

Vote: Motion passed 7-2: Yes –Jim Barnes, Randy Brownrigg, John Drabinowicz, Joyce Goodwin, Jon Maltz, Stuart Schniederman, Ted Trost; No – Ted Luszey, Stephen Nute.
