- 1. The meeting was called to order at 7:00 PM.
- 2. NM led the Pledge of Allegiance.
- 3. Superintendent Randy Bell addressed the action items requested by the Budget Committee re: 1) student-teacher ratio and class size and 2) the figures involved in the decision to increase the per pupil cost of consumables from 35.00 to 40.00.
- 4. JG made a motion to remove from the table the budget for The School District for the Town of Hudson in the amount of 45,142,267.00. CS seconded the motion. The motion carried (11-0-0).
- 5. The Alvirne High School budget was reviewed. Mr. Lane presented and explained the budget. A lengthy discussion re the purchase of boards (ie which kind and why) was discussed. Technology needs were highlighted. The positive progress made re the Alvirne Farm being more economically self sufficient was reviewed. - 13. JG made a motion to amend details number 117-10152410 Hills Garrison School secretarial overtime by striking 2,076.00 and inserting 0.00 (a decrease of 2,076.00). JD seconded the motion. Discussion followed. The motion carried (9-2-0).

- 17. JD made a motion to lay on the table the Town of Hudson School District Budget in the amount of 45,110,649.00. CS seconded the motion. The motion carries (11-0-0).

TL made a motion requesting information re what are the state requirements for technology plans as well as what the FCC regulations are re the requirements causing us to replace radios throughout the school.
