2. Public Input – None
3. Selectman Jasper presented the warrant article for the collective bargaining agreement for the Highway Department. Selectman Jasper moved to recommend Warrant Article B, seconded by Bob Haefner.  
Passed 8-1.
4. Selectman Jasper presented the warrant article the collective bargaining agreement for the Town Administration and Support Union. Selectman Jasper moved to recommend Warrant Article C, seconded by Richard Nolan.  
Passed 8-1
5. Selectman Jasper presented Warrant Article L, a capital reserve fund for the purpose of the management of invasive species at town ponds. Selectmen Jasper moved to recommend Warrant Article L, seconded by Bob Haefner.

6. School Board representative Richard Nolan presented a statement on the school contracts.
7. Superintendent Randy Bell presented the warrant articles for the school collective bargaining agreements.
8. Richard Nolan Moved to recommend Warrant Article B, the collective bargaining agreement with the Teachers Union, seconded by Normand Martin.  
Passed 5-3-1.
9. Selectman Jasper moved to table Warrant Article C until the meeting on January 5<sup>th</sup>, seconded by Normand Martin.
