

# Budget Committee (BC) Public Hearing Meeting Minutes January 14, 2021 FINAL

## a. Overview and Public Comment of Town Budget – Default Budget

- WA15 Establish Hills Memorial Library capital reserve fund: Motion made by Mr. Trost second by Mr. Fedele. Motion passed (10-0-0).
- No vote was taken on WA's 1, 2, 16, 17, 18, 19, 20, 21 or 22 for the Town as there is no tax/budget impact.

  - WA05 Partial Roof Replacement at Hills Garrison School: Motion made by Vice-Chairman Goode second by Mr. Fedele. Motion passed (10-0-0).
