

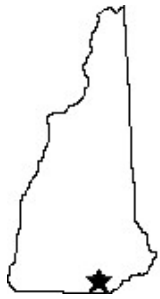

Motion by Mr. Cole, second by Mr. Jasper, to request all invoices regarding the firm NRPC for FY 22 1 July 21 to 30 June 22. Motion carries unanimously 10-0-0

Motion by Mr. Cole, second by Mr. Clegg, for the agreed upon conditions of site plan 1222 Hudson Logistics Center. Motion carried unanimously 10-0-0

Motion by Mr. Cole, second by Mr. Jasper, for the Budget Committee Chairman to

arrange a joint meeting with the Board of Selectman, and Hudson School District to review and understand the laws and how they affect all the money that comes into each entity. Motion carries unanimously 10-0-0.
