#### F. New Business

Motion by Mr. Jasper 2<sup>nd</sup> by Mr. Murray to separate the offices of Town Clerk/Tax Collector to Town Clerk budget and Tax Collector Budget as the offices will exist separately as of 1 July 2024. **Motion Carries by raised hand vote 9-0**

Motion to **reconsider** the vote to reduce the Assistant Town Administrator salary line 5110-101 by Mr. Walsh 2<sup>nd</sup> by Mr. Murray. **Motion carried 5-4** Mr. Jasper, Ms. Leary, Ms. Whiting, and Selectman Morin opposed.

Motion to by Mr. Cole 2<sup>nd</sup> by Mr. Walsh to reduce line 5110-101 Assistant Town Administrator from \$182,851 dollars to \$0 dollars. **Motion fails 4-5** Mr. Jasper, Ms. Whiting, Ms. Leary, Mr. Lawrence, and Selectman Morin opposed.

Motion to reduce line 5200-218 Legal Fees by Mr. Cole 2<sup>nd</sup> by Mr. Lawrence from \$93,000 dollars to \$85,000 dollars, a reduction of \$8,000 dollars.

Motion to table the line-item reduction of 5200-218 Legal Fees by Mr. Lawrence 2<sup>nd</sup> by Mr. Jasper. **Motion carried 9-0** (12-6-2023 meeting follow up.)

Motion to reduce line 5200-278 by Mr. Cole 2<sup>nd</sup> by Mr. Murray from \$16,000 to \$7,000 dollars, a reduction of \$9,000 dollars. **Motion fails 3-6,** Ms. Leary, Mr. Martin, Mr. Jasper, Mr. Walsh, Ms. Whiting, Selectman Morin opposed.

Motion to adjourn by Mr. Murray  $2^{nd}$  by Mr. Martin, motion carried by voice vote unanimously.
