

**Requests Made for Reduction in General Fund Line items in the 2023 Budget**  
**Duplicative to or Parallel Activity Paid With or Originated from ESSER Grant Funding**

*Please remove this position from the general fund. It is unjust to expect taxation to support yet such a duplicative, unnecessary, non educational expense. The role of this proposed position is duplicative to the numerous counseling and social emotional positions added to the budget with the ESSER grant. This is an unnamed staff position ADDED by the school board during the HMS and AHS presentation of 2023 budget on 10/25/21 ~~11/16/21~~. A discussion during this meeting shows this second mental health professional was requested as a result of perceived additional needs due to COVID. The additional position is listed on a formal list of budget changes as being added to 10001100112, which is where the district already has a mental health coordinator. However, it ended up on this line item in the updated budget, which is a special education line item. The ESSER III grant application already provides for adding THREE additional **certified school counselors** whose role will be to “provide support for students and families transitioning back to fully, in person learning, and support social emotional learning.” The ESSER III grant application also provides for adding an additional THREE certified Social Emotional Interventionists, whose roles will be to “support learning from Pre-K to first grade.”*

*The ESSER II grant application provides for PANADOC Software “to provide for **contactless** signing of documents, contracts and IEPs for staff, parents, the school board and other entities throughout the district. This software clearly originated as a result of COVID precautions and was originally paid with ESSER grant funding. If the need for such provision and precautions remains, the continued cost should come from the lavish ESSER III funds available.*

*It appears from ESSER grant language that iReady had replaced RENNAISSANCE STAR diagnostic tool. There was ZERO expended in 2021.*
