# American Rescue Plan Act (ARPA) Project List November 1, 2022

**Flagstone Drive Drainage Replacement** - This project was for the replacement of approximately 1,200 linear feet of failing 24-30 inch galvanized pipe under Flagstone Drive. This project is complete.

West Road Transfer Station – This project was for upgrades to the transfer station at West Road to ensure compliance with NHDES requirements, and safety requirements as well as more efficient traffic flow, and better dumpster layout and access. This project is complete. \$5,000 has been held back until the spring of 2023 for minor asphalt repairs.

**Lowell Road Bridge/Culvert** – This project was to extend the life of the NHDOT red listed bridge/culvert over First Brook on Lowell Road near Central Street. This project consists of lining the bottom of the galvanized pipe which will extend the life of the bridge/culvert by 15 to 20 years. The construction phase for this project has been put out to bid with a November 10 2022 due date.

**Taylor Falls/Veterans Memorial Bridge Rehabilitation** – This project is for the rehabilitation of the Taylor Falls and Veterans Memorial bridges. We have been informed that State funds, specific for bridge projects, will provide the funds needed to complete this project thus these funds are available to be repurposed to other qualifying project(s).

**Seagrave Fire Apparatus** – This was for the additional cost needed to complete the construction of the replacement Fire Engine. The Town has taken delivery of the Fire Engine.
