Budget Committee Meeting Minutes January 3, 2024

A. Call to Order

Chair Normand Martin called the meeting to order in the Buxton Community Development Room at Town Hall at 6:30 pm and declared that a quorum was present.

H. New Business

Motion by Mr. Cole 2nd by Mr. Quinlan to reduce the overall budget from \$67,533,361 to \$63,392,486, a reduction of \$4,140,875. Motion fails 4-6, Ms. Whiting, Ms. Leary, Mr. Walsh, Mr. Jasper, Mr. Lawrence, and Selectman Morin opposed.

Motion by Mr. Jasper 2nd by Selectman Morin to remove all new Fulltime equivalents from the budget, and parttime equivalents to fulltime equivalents only remove the delta which is \$1,081,438 leaving a school budget of \$66,451,923. Motion carries 7-3, Ms. Whiting, Ms. Leary, and Mr. Walsh opposed.

Motion by Mr. Jasper 2nd by Selectman Morin to recommend Warrant Article 2, motion carries 6-1-3, Mr. Jasper opposed, Ms. Leary, Mr. Murray, and Mr. Cole abstained.

Motion by Mr. Jasper 2nd by Mr. Walsh to recommend Warrant Article 3, motion carries 7-1-2, Mr. Jasper opposed, Mr. Murray and Mr. Cole abstained.

Motion to adjourn by Mr. Lawrence 2nd by Mr. Jasper, motion carries 10-0-0 and the Hudson Budget Committee is adjourned at 8:03 pm.
