










## Change Planning Board Membership from Elected to Appointed

If adopted, all future Planning Board members shall be appointed by the Hudson Board of Selectmen in accordance with RSA 673:2 and RSA 673:5, with terms established pursuant to state law.

Current elected members shall serve out the remainder of their elected terms, after which vacancies shall be filled by appointment by the Board of Selectmen.
