b. Alvirne Field Update

Mike shared that final testing is completed for checking the fiberoptic cable's video feedback from AHS field to HCTV center, making it possible to stream internet and cable live, with added instant replay function, using the HCTV mobil unit.

c. HCTV Camera Operators

Jim McIntoch reported that he has recently completed the interview process and is ready to submit the names of the most qualified candidates for the position of camera operator. Roger Coutu stated that he can present the recommended candidates, on the basis of interviews supplied by Jim, to the BOS at tomorrow night's meeting. The committee agreed that Jim and Roger continue with said process.

7. New Business

a. CUC FY 18 Budget

Mike reported that Kathy Carpentier (Finance Director) and Steve Malizia (Town Administrator) have informed him that there will not be a CUC FY18 Budget review due to the passing of the recent warrant article which initiated a CUC Revolving Fund (consisting of 80% of franchise fees, with remaining 20% going to the Town). Mike shared with the committee a drafted FY18 budget for review and open discussion.

b. Facilitator Report

Jim McIntoch informed committee of last two month's happenings: Jim's desktop computer needed to be replaced; the NHCM annual meeting held at HCTV and Benson Park, for the second time, was a well-received success; HCTV janitor position is open; investigating recent "cracks' in the walls for possible repair and painting; enrichment students HMS are scheduled to complete a project called "Napoleon Dynamite" with a wrap-up party on September 26.
