# I. OLD BUSINESS

A: Wetlands Special Exception Application- Bluebird Self Storage,256 and 266 Lowell Road Map 228, Lot 007 and Lot 008 Zone Business (B)

**Description of work to be performed:** The project proposes construction of a 112,500 sq.-ft. climate controlled self-storage facility, driveway and parking areas surrounding the facility and a detention pond to manage storm-water runoff. As built the roadway and storm-water Detention Pond will have permanent wetland buffer impact of 15,154

Note: Prior to tonight's presentation four members of the HCC performed a site-walk to evaluate the current conditions and the quality of the wetlands. No outstanding findings were noted such as evidence of rare or endangered species or rare and endangered flora and fauna.

Mr. Tony Basso of Keach-Nordstrom Associates presented plans for the proposed construction of a new climate controlled self-storage facility to be located at 256 and 266 Lowell Road. Mr. Basso explained that the driveway construction would permanently affect 8,024 sq.-ft. of wetland buffer located on the westerly side of Lot 007 and construction of a new storm-water detention pond would permanently affect 7,130 sq.-ft. of wetland buffer located along the southerly portion of Lot 007. Total combined permanent wetland buffer impact of the proposed project is 15,154 sq.-ft. After thorough questioning by commission member the majority of members present were satisfied that the wetland buffer impacts would have no detrimental effect on the wetlands themselves and that they should continue to function to dissipate storm-water runoff from adjoining properties. It was decided to favorably recommend that the Wetlands Special Exception Application filed by Bluebird Self Storage, LLC which requires a permanent wetlands buffer impact of approximately 15,154 square feet be excepted with the following stipulations.

- 1. Construction and restoration shall comply with: BEST MANAGEMENT PRACTICES TO CONTROL NON-POINT SOURCE POLLUTION: A GUIDE FOR CITIZENS AND TOWN OFFICIALS (NH Department of Environmental Services-Current Issue.)
- 2. During construction and restoration erosion control barriers shall be installed and maintained to the satisfaction of the Town Engineer.

**Dissention Reason(s):** Paula Hubert and Michael Tsu both voted unfavorably stating that this project may not be the best use for the property. They further stated that the commission should be encouraging developers for more conservation in wetland districts.

# **II. NEW BUSINESS**

# A: Wetland Special Exception Application – First Choice Landscaping, LLC, 78 Highland Street; Map 175, Lot 019- Inquiry and Introduction

Bruce Gilday, of BAG Land Consultant and representing Chris and Christine Floyd came before the commission seeking a favorable recommendation for an "after the fact wetlands special exception". Mr. Gilday informed the commission that the Floyd's had filled both the wetland buffer and about 2000 sq.-ft. of forested wetlands behind their property and were know looking to keep the fill in place. He went on to describe the current conditions stating that seed had been planted and the slope leading down to the wetlands had been stabilized. It was decided by commission members that a sitewalk of the property was warranted to evaluate current conditions at 78 Highland Street was set for September 20, 2017 at 6:00 p.m.

# B: NH DES Wetlands Permit Application for Signature; Map 251, Lot 001-000 Limit Brook Bank Stabilization beneath and adjacent to Entrance Drive at BAE PTP, 65 River Road.

**Description of work:** To armor the easterly bank of Limit Brook beneath and adjacent to the entrance road bridge. The expected bank disturbance is estimated to be eighty-seven feet. The project will stabilize the stream bank and prevent further erosion protecting the integrity of the entrance bridge. There is also a beaver dam and large rocks which will be removed from the stream itself to lesson any restriction of flow.

Timothy Ferwerda, of Meridian Land Services Inc. and representing BAE Systems came before the commission seeking a signature from the HCC Chairman on a DES Wetland Permit Application. Mr. Ferwerda gave a short presentation on the type of work to be completed and answered questions asked by commission members. With all matters concerning the project being addressed a motion was made by Mr. Collins and seconded by Mr. Veloso authorizing the acting commission chairman to sign Section 12 of NHDES Wetland Application Titled Limit Brook Bank Stabilization.

Mr. Dhima stated that the Selectmen would be looking for budgets that are level funded and added that commission members should consider using monies that are still available from the present budget to make such purchases.

Further discussion on the matter was deferred till the October meeting
