T Basso of Keach-Nordstrom Representing Eagles Nest States LLC

Prior plan was for development of large amount of the property acreage

Impact was for 11 wetlands crossings. With large areas of impact to wetlands and buffers approximately 27 acres of land was open space.

New plan (conceptional) reduces the crossings to 4. Anticipated Wetlands Impact: 4865 sq ft. Permanent. And 55,000 sqft (approximately) buffer – less than half of the previous plan.

J Battis - how will the conserved lands be managed?

T Basso - there are options that need to be discussed.

Gove – mapped the wetlands.

Site Walk Scheduled for October 30 at 11: 00 to 1:00 PM

Enter off of Bush Hill Road onto dirt (white) road, hunting season open – wear bright colors.

Visual color maps handed out displaying Robinson Pond condition prior to and after DASH unit activity. Project those 30 days of activity required to reduce Pond infestation to a good level. After would require 5 to 10 days a year to maintain a good level

Ottarnic Pond in good shape – will require 5 to 10 days a year to assure a good level.

Budget – not there for the 30 days. Will need to find other sources of income. Also project a \$15,000 shortfall for fy-2013. Need to put together a plan to provide funding. Herbicide treatment at Robinson Pond was “disappointing”.
