#### II. OLD BUSINESS

A. Map 184 Lot 032; 109 Belknap Road, Hudson NH, Request for wetlands Special Exception, to disturb 29,195 square feet in the buffers. Master Plan – Oak Ridge Condominium, a 55 and Older Community Owner K & M Developers, LLC; 46 Lowell Road Hudson NH H.R.C.D Vol.8199 pg1398 Engineering Firm: Keach – Nordstrom Associates, 10 Commerce Park North Bedford, NH 03110

Discussion: Presentation by T Basso of Keach Nordstrom Six wetlands on site. Four affected. Buffer impacts for storm water control only. Review of each of four affected areas. Site walk conducted on site. Will use natural bottom arch at Vernal Pool at Southwest corner. Clear-cut area adjacent to Benson- concern with buffer not providing adequate protection for view.

Propose that the area not being developed be put into a conservation easement. Buffer area will be seeded with a conservation mix. By laws will require that only sediment be removed from the detention pools. Enforcement will be the Town's responsibility, except the stormwater maintenance is a federal requirement. Records will be kept by condominium association. RV & boat storage area – will be fenced in with a screen fence. Any overflow of vehicles will be stored off site.

Motion to recommend WSE in accordance with the plan with stipulations: Motion By; T Quinn

Second By: M Champion

- Property south of the tree line as marked on the plan will be put into a conservation easement
- A bottomless arch will be used from the vernal pool to the drainage to the south under Brody Lane.
- Seeding in the restored areas will be with a conservation mix.
- Maintenance of the retention pool area will be for sediment; no mowing will be Allowed
- Three parking spots will be removed adjacent to unit 88
- 6 Best management practices.

Vote 5 – 0 -1 L Kipnes abstained
