#### VI. Old Business

A. Sign placement at entrances to the conservation properties around town.

Commission members present looked favorably on placing road side signs at the entrances to the various conservation properties. The purpose of these signs will be to provide better visibility of conserved land entry points for the public traveling along town roads. Mr. Dickinson move to spend an amount not to exceed \$600.00 form account 06-4619-5586-202-000 for the purchase of these signs and their installation hardware. Motion was seconded by Mr. Brownrigg. Motion carries 5/0/0

C. Ribbon Cutting for 68 Pelham Road.

Mr. Collins provide fellow members with a quick update in regards to the ribbon cutting ceremony for the newly acquired conservation property located at 68 Pelham Road. He said that the property and trails were in good shape. Mr. Collins thanked Selectman Morin for the idea and added that he was looking forward to event.

**E.** Presentation of a Warrant Article for consideration by the voters of Hudson pertaining to a change in the number of sitting HCC members.

Mr. Gagnon present a draft copy of a Warrant Article to address the number of sitting members on the Hudson Conservation Commission. His draft Warrant Article will read as follows.

"Shall the Town vote to increase the current membership of the Conservation Commission from 5 members to 7 members as permitted by RSA 36-A:3"

Mr. Collins moved to accept the draft warrant article as written and to forward this article to the Board of Selectmen for consideration and inclusion on the town ballot for the year 2020. Mrs. Parkhurst seconded the motion. Motion carried 5/1/0. Chairman Brownrigg voted in opposition to this motion stating that a five member board seemed adequate to conduct commission business

### VII. New Business

A.Wetlands Special Exception Application for Friars Drive, Map 209, Lot 001-000

Applicant Representative Attorney Thomas Leonard appeared before the commission seeking its

recommendation to approve a new Wetland Special Exception application for Friars Drive. Attorney Leonard explained that this new application supersedes the previously approved WSE and was need to document a wider road width and increased wetland buffer disturbances.

Mr. Collins moved to recommend to the Zoning Board of Adjustment the granting of the revised Wetland Special Exception as part of the extension of Friars Drive, which includes the reconstruction plans to reflect the 32-foot curbed width for the proposed multi-family development at 161 Lowell Road, Map 209/Lot 001. The Conservation Commission recommends that the Wetland Special Exception be granted provided the applicant follows Best Management Practices. The motion was seconded by Mr. Dickinson and carried 5/0/0

B. Boy Scout Bridge Project

Boy Scout Benjamin Romanek and Scout Leader Joseph Undercoffler appeared before the commission seeking permission to construct two bridge crossings at the northern end of the Musquash property near Woodland Drive. The construction of these bridges are part of Mr. Romanek's effort to achieve Eagle Scout honors. Being familiar with similar projects completed by the Boy Scouts on this property commission members granted permission for Mr. Romanek and Mr. Undercoffler to proceed and wished them success.

#### **VIII. Other Business**

A. Musquash Conservation Land- Bridge Replacement/Repair

Commission members present looked favorably on replacing a bridge near Second Swamp (Musquash Conservation Land). Replacing the bridge will join land owned by the Pelham Conservation District and the town of Hudson and will allow hikers expanded trail access. Mr. Collins move to spend an amount not to exceed \$1000.00 form account 06-4619-5586-252-000 for the purchase of materials to construct the bridge. Motion was seconded by Mr. Parkhurst. Motion carries 5/0/0
