





After conferring with Attorney Lefevre (see the email string below) it appears that the correct process for the Conservation Commission to conduct a timber harvest at the Rangers Drive Forest would be to have the company conducting the cutting/harvesting fill out the Notice of Intent with Assessing. After the work is complete, the report of the cutting/harvest would be completed and Assessing would calculate the yield tax due. That bill would then be placed on the Board of Selectmen's agenda with a request for a waiver of the tax, which the Selectmen could grant. Please let me know if you have any questions.

Steve, I think conceptually the company doing the cutting has to file a Notice of Intent, but the Town can then waive the tax.

Per RSA79:3-b "When timber harvesting is conducted on land owned by, and located in, a municipality, the municipality may waive the yield tax, but shall report the location, species, and volume of wood and timber cut to the commissioner of revenue administration, who shall send one copy of the report to the division of forests and lands of the department of natural and cultural resources."

I also think that is what the agreement with the conservation commission says, i.e. the contactor will file a Notice of Intent.

Just want to confirm something. The Conservation Commission wants to conduct a timber harvesting at the Rangers Drive Town Forest. The way I read RSA 79:1 II(b) (3) it appears that the Town is not required to file an intent to cut or subject to the tax imposed by this chapter. I'm interpreting this to mean that the Conservation Commission does not need to file an intent to cut nor pay any timber tax on what is harvested. Am I interpreting the statute correctly?





# NHACC supports state certification for Wetlands Scientist

NHACC has reviewed the <u>Governor's Proposed Licensure and Regulatory Reform</u> that would eliminate more than 30 professional licenses and certifications in NH, including Forester, Soil Scientist and Certified Wetlands Scientist. We believe that requiring professional standards for these occupations is essential to protecting NH consumers and our most critical natural areas. Repealing the standards for professional scientists would be detrimental to land use boards striving to use current data and accurate information in the decision–making process. We will be sending letters to Governor Sununu, the House Finance Committee and the House Executive Departments and Administration.

# Points made from the proposal come from language in HB655.

HB655 This bill redefines the roles and responsibility of the Office of Professional Licensure and Certification (OPLC). The bill consolidates administrative rules as advised by the boards and commissions and repeals redundant provision in the law and would eliminate licenses which OPLC believes can be handled by a national or professional mechanism to replace state licensure. HB655 was recently discussed in the House Executive Departments & Administration (ED&A) committee work session to review options for repealing licenses and certifications in NH.

While removing redundant laws sounds reasonable, it is important to note that most membership organizations rely on dues for their income so there is an obvious conflict of interest for impartial certification standards. State wetlands certification is much more rigorous than professional association standards and requires knowledge of state rules and regulations. In the case of Certified Wetlands Scientist, the national organization has a certification program but it does not deal with state regulations or any regional information. Knowledge of NH law is critical to completing accurate wetlands permit applications and without sufficient understanding of DES Wetlands Rules, they will not be able to professionally advise their clients.

Another one of the arguments for repealing licenses was based on the lack of complaints received by the approval board. This logic assumes that if they don't hear about any bad actors that the profession does not need to worry about fraud. Typically, the lack of complaints shows that the process is working to regulate the activity and that the program is helpful for our citizens. If things are working you don't get as many complaints. The ED&A committee did voice concerns about regulating negligence and incompetence and asked how the proposed bill language would ensure NH consumers are protected.

Another point was made to help make it easier to enter the workforce in NH by removing burden and barriers for professions. The idea of relaxing professional standards to help increase the work force does not consider public and consumer protection or safety.

# **Next Steps**

NHACC sent a <u>letter to the Governor</u>, the House ED&A committee and the House Finance committee. The budget (HB2) should be ready by the end of this week and we will keep you posted on the language that gets inserted into HB2. The ED&A committee believes it would be ok move the administration of licenses to OPLC as a proposal in HB2 as long as certification standards remain in the language.

The ED&A Committee will research questions about certifications and some committee members believe these issues should be dealt with separately in HB655. HB655 has to be out of committee by Mid-March so they don't have much time to find answers.

These projects hold strategic conservation and economic value for water quality, forestry, outdoor recreation, and wildlife habitat. With your support, the Forest Society's recently...

- Protected two properties totaling 482 acres adjacent to the Forest Society's 457-acre Evelyn H. & Albert D. Morse, Sr. Preserve in Alton, enlarging the Morse Preserve and creating a connected corridor of conservation land encompassing 1,250 acres at the southern end of the Belknap Mountains.
- Conserved the 273-acre Ammonoosuc River Forest in Bethlehem with 1.8 miles along one of the state's iconic rivers. This spectacular property abuts the White Mountain National Forest, and features an important cold-water fishery, scenic views, and outstanding opportunities for additional recreational pursuits.



## I. Old Business

# a. HCC Logo Contest - Art Work Evaluation

Chairman Collins asked if there were any revisions needed to the selected logo regarding graphic design (color, etc). Mrs. Rumbaugh suggested that the letters "HCC" be added to the bottom, simplfy logo graphic if possible, and use only a few basic colors to keep duplication costs at a minimum. Mr. Dickinson suggested that the logo have "Hudson" added to the bottom of the logo and noted that the image should be altered in Adobe Photoshop in effort to add text, clean and sharpen the image, etc. Mr. Dickinson intends to review the image and provide comments to Chairman Collins prior to our next regular meeting. Chairman Collins will present two versions of the image with HCC and Hudson CC at the next meeting (March 13).

# b. Rangers Town Forest Tree Harvest

Mrs. Rumbaugh presented email correspondence provided by Eric Radlof, Full Circle Foresty. Landing area, general timing of harvest, abutter notification, and potential deferral of timber tax were discussed. Landing area is typically ¼ acre with a stone apron and is reseeded upon completion of harvesting activities. Landing area costs (approximately \$3,000) are shown as a deduction line item from the timber harvest profit report. Chairman Collins and Mr. Murphy expressed interest in maintaining the landing area as an open field. Harvest could potentially occur in late spring or early summer. Mr. Dickinson noted that timber harvest activities typically occur after mud season as our previous harvest at Kimball Hill Town Forest occurred in early summer due to an extended mud season.

Chairman Collins will communicate this week with Mr. Dhima, Town Engineer, who will prepare a signed work order for Full Circle Forestry if it has not been processed already. Although a minimum of 30 days notification is required, Chairman Collins preferred to notify residents and hikers much earlier with temporary legible signs. Mr. Pinsonneault volunteered to create an Abutters List. Mrs. Rumbaugh volunteered to draft an Abutter Notification Letter. Chairman Collins asked Mr. Murphy to obtain a quotation for five Forestry Notification Signs to be placed at trailhead locations. Email correspondence provided by Jim Michaud, Town Assessor, was discussed regarding Timber Tax deferral. Selectman Morin will add an agenda item to the next available BOS meeting to discuss the possibility of deferring the 10% NH Timber Tax.

c. Abutting Land Owner Access Form = Item Deferred to our next regular meeting in effort to allow for more review of the revised draft.

#### **II. New Business**

#### a. House Bill 592-FN

After a brief summary of the proposed bill, Chairman Collins noted that it failed in the House Review Committee Meeting 2/1/23, therefore no response is necessary. Chairman Collins recommended that all HCC members sign up for future NHACC email notifications.

## III. Other Business

# a. Trail work day

The conservation commission will hold a trail work day at Kimball Hill Town Forest this Sunday March 12, 2023 from 8 AM – 12 PM. Work emphasis on removing old tires, steel drum and other items from the wetlands and associated wetland buffer area in the recently acquired parcel. Remove tree at bottom of Ravine Trail and potentially work on new connector trail. The public is welcome to attend. Mr. Dickinson may email other members to organize small trail work tasks prior to our next regular meeting (March 13). Chairman Collins thanked all attendees of our previous work day at Rangers Town Forest for their effort in removing a large amount of illegally dumped items from the property. He also recommended that we create temporary signage for future work days. Mr. Dickinson suggested purchasing orange construction cones to mark roadside trash piles. Mr. Murphy suggested to attach temporary signage to "election style" aluminum frames. Chairman Collins tasked Mr. Murphy with obtain quotations for the temporary signage.

# b. Trail Work Log

Mr. Dickinson presented the initial 2023 Trail Work Log which was created on January 15 and revised on February 12. This is intended to be a live document which is updated monthly. All members are encouraged to email Mr. Dickinson in effort to track all timber downfall removal and other trail work activities. Mr. Collins noted that several trees were removed from Colburn and Musquash Conservation Areas on January 14. Mr. Dickinson will add several downfalls along the Hamblett-Nash Trail and Monadnock Vista Trail to the list. Mr. Murphy suggested that we add additional signage and/or markings on the Hidden Ridge Trail. Mr. Collins requested that the Trail Work Log be uploaded to the Resource Page on our website. There was a brief discussion regarding future projects and general usage of Merrill Park as well.

# IV. Financial Status

No new monthly expenses recorded. Approximately \$11,000 was recently approved by the

BOS for aquatic vegetation removal. Chairman Collins noted that there should be professional service funds available for removing invasive vegetation in upland areas, i.e. Rangers Town Forest. Mr. Dickinson intends to obtain quotes for removing invasive vegetation along trails prior to the next regular meeting. Chairman Collins noted Saving Special Places workshop will be held on April 15. There is some remaining money available for Registration Fee reimbursement.

Conservation Fund = \$756,129.

# V. Correspondence

The Chairman reviewed the correspondence which included the following.

A letter from Susan Rouke requesting a future community garden area. Chairman Collins replied to Mrs. Rouke that no specific open area was currently available in Town Conservation Areas, however he encouraged Mrs. Rouke to form an interest group in effort to establish a community garden or partnership possibly on privately owned agricultural land.

# VI. Approval of Minutes

Mr. Dickinson moved to approve the meeting minutes for January 9, 2023, and January 14, 2023. Mr. Pinsonneault seconded the motion. Motion Carried 5/0/0

# VII. Commissioner's Comments

Mr. Pinsonneault noted that there is one more duck box to install at Musquash Pond. Selectman Morin requested that another person be present for safety purposes. He will obtain a larger swamp boat to facilitate installation. Chairman Collins inquired about installing a game camera. Mr. Pinsonneault noted that we should monitor the usage of the duck boxes prior to game camera installation.

Mrs. Rumbaugh reminded everyone that it is possible to get a Poison Ivy rash in the winter.

Mr. Dickinson requested that we update the 2012 Open Space Master Plan and encouraged others to occasionally review Conservation Commission minutes from other NH communities in effort to further educate our commission on current topics, activities, etc.

Chairman Collins reminded everyone to review the Natural Resources portion of the revised Town of Hudson, NH Master Plan. Email comments to Brian Groth, Town Planner. The Master Plan revisions will be discussed at the March 3, 2023 Planning Board meeting. Chairman Collins noted that the map on Page 32 should be revised to reflect recently

purchased open space lands.

Selectman Morin requested that we update the Open Space Master Plan simultaneously with the Town of Hudson, NH Master Plan.

Chairman Collins encouraged our commission to pursue land acquisition in the Robinson Pond Watershed Area. He also looks forward to our upcoming trail work efforts.
