Hudson Municipal Utility Committee Meeting Minutes

The monthly meeting of the Town of Hudson Municipal Utility Committee was held Tuesday, April 17, 2018 at 7:00 pm, in the Board of Selectmen meeting room at Town Hall. Secretarial duties were provided by Donna Staffier-Sommers.

Our new Committee Selectmen liaison is Marilyn McGrath. Selectman Martin received tonight's meeting packet in error and offered to come to the meeting since Selectman McGrath did not receive the information from us. Our apologies to Selectman McGrath.

1. Acceptance of minutes

The minutes of the March 20, 2018 Municipal Utility Committee meeting were reviewed and corrections noted. A motion was made by Bill Abbott; second by Jim Lavacchia to "accept the meeting minutes for meeting dated March 20, 2018, as corrected." Motion carried with Chelsea Leonard abstaining.

3. Financial Status – Water Utility

A – D. The Cash Flow reports for February 2018 and the Expenditure & Revenue reports

for March 2018 were reviewed. Jim had some questions about a few of the expenditure lines and what they cover so it was agreed that Donna would forward him copies of the water and sewer budgets containing the explanation sheets.

The Pennichuck Operations report for March 2018 was reviewed. Jim pointed out an incorrect amount shown under the Planned Work Completed during March activity as shown on page 9. Purchase chemicals for Weinstein Well is shown at 6378. Elvis to follow up.

5. <u>New Business – Water Utility</u>

A. Abatement

W-UTL-18-03 (3/23/18) Williams 3 Canna Path #3501381401

Customer was billed \$225.00 for an after-hours service call but the water leak was found to be on the Town's side. Request abatement of \$225.00.

Motion made by Bill Abbott; second by Chelsea Leonard "to recommend the Board of Selectmen approve abatement W-UTL-18-03 in the amount of \$225.00 for the reason given. Motion carried.

6. Financial Status – Sewer Utility

- A. The cash flow report for February 2018 and the Expenditure and Revenue reports for March 2018 were reviewed with minimal discussion.
- B. The balance of capacity is at 69,500 gpd.

7. Old Business – Sewer Utility

A. Abatement

S-CAP-18-02 Town/Trudel/Sinclair 10 Flying Rock Rd m/l 185/009 #9990

This abatement request was deferred from the last meeting to get additional legal opinion. The former owner/builder of this property entered into a payment agreement for the sewer capital assessment in 2004 and failed to make payment upon transfer of property and subsequent sales also left this unpaid. The Town Attorney has reviewed and deemed the balance as uncollectable. Request abatement of \$2131.25.

Motion made by Bill Abbott; second by Chelsea Leonard "to recommend the Board of Selectmen approve abatement S-CAP-18-02 in the amount of \$2131.25 for the reason given. Motion carried

A. Bill Abbott provided the Committee with a 12 month profit and loss statement for both water and sewer.
