

Meeting minutes of October 17, 2012

1. CALL TO ORDER - The meeting was opened by Chairman Jeff Rider at 5:03 PM in the Board of Selectman's conference room at Hudson Town Hall.

2. ROLL CALL

- 3. PUBLIC INPUT No input from the public was received
- **4. ACCEPTANCE OF MINUTES -** Minutes of Water Utility Committee from September 15, 2012. Bernie Manor requested a correction on section 11 (Remarks by Selectman & Staff) In particular, Correcting Selectman Nadeau and WU clerk Marquez status from "No remarks" to absent. Motion by Bernie Manor to accept the corrected September 15, 2012 meeting minutes. Motion seconded by Leo Bernard. Motion passed (4-0).

5. FINANCIAL STATUS

- A.) Expenditure report, September 2012
- B.) Check register for September 2012
- C.) Cash flow report August 2012

The committee noted that item B (Check register) was not included in the monthly packet.

Chairman Rider questioned the value of reviewing the WUC treasurers' reports. After a brief discussion, the committee agreed that the check register contained the pertinent financial information needed for review and that future treasurers' reports (Revenue, report and expenditures) could be removed from the monthly WUC review packets in order to reduce waste.

Bernie Manor questioned the -3,318.18 bank charge against fund 03-3502-4702. Chairman Rider directed the committee to the negative balance for water operations and maintenance (Expenditure report, account # 03-4332-5592-205)

Motion by Bernie Manor to accept consent item 5 (Financial Status) in its entirety, with above noted exceptions. Motion seconded by David Shaw. Motion passed unanimously (4-0)

6. OPERATIONS REPORT (PWW)

A.) August 2012


Motion by Bernie Manor to accept the August 2012 Operations report. Motion seconded by David Shaw. Motion passed unanimously (4-0)

7. OLD BUSINESS

- A.) <u>Check payments to TV0XXX vendors</u>: The TV acronym stands for "Temporary Vendor", and is typically refunds to water customers.
- B.) <u>Computer maintenance fee</u>: The proposed \$250 annual maintenance fee (\$125 each water and sewer) was actually \$250 each water and sewer (the exact amount is \$427.50 for each computer). The \$450 is the budgeted amount.
- C.) <u>Irrigation installations</u>: The committee reviewed the sewer department outside water users policy (http://www.hudsonnh.gov/departments/sewer/outside-water-users) regarding deduct meters. The policy states that a licensed plumber must apply for a deduct meter permit. Chairman Rider reiterated his concern that homeowner-installed sprinkler systems (customers on town water, but not sewer) could be installed without the deduct meter.

8. NEW BUSINESS

A.) <u>Credit card payments</u>: The town is considering a credit-card payment option for water and sewer customers. The payment software would be provided by Harris Local Government http://findaccountingsoftware.com/directory/harris-local-government/munismart-systems/ The town wants to implement this option this fiscal year, but did not budget the \$1250 licensing fee:

The town is proposing paying both the \$300 one-time services fee and monthly \$100 administration fee, but splitting the \$1250 licensing fee between water and sewer (\$775 each).

Visa credit cards will not be accepted (at this time) by the Harris system and Chairman Rider clarified that last-minute customer credit card payments (to avoid shut-off) would still be paid to the town if the customer disputed or challenged the payment at a later date.

Motion to accept the proposed credit card system for water customers by Bernie Manor. Motion seconded by David Shaw. Motion passed unanimously (4-0)
