Approved Hudson Sewer Utility Committee Meeting Minutes

Date of Meeting: February 9, 2012

The regular monthly meeting of the Town of Hudson Sewer Utility Committee was held Thursday, February 9, 2012, at 5:02 pm, in the Board of Selectmen meeting room at Hudson Town Hall. Bernie Manor presided as Chairman. Secretarial duties were provided by Donna Staffier-Sommers. The minutes of the previous meeting were read and approved with no corrections required. 4. New Business

A. Sewer acceptance- 109 Belknap Rd M/L 184/032

This is phase one – 25 units with private sewer. The sewer acceptance is for units 1-8, 53-58, 79-85 and 97-100.

Motion was made by Jeff Rider 'to recommend acceptance of the sewer line as presented", second by Leo Bernard. Motion carried unanimously.
