


Hudson Municipal Utility Committee Meeting Minutes

The monthly meeting of the Town of Hudson Municipal Utility Committee was held Tuesday, April 18, 2023 at 7:00pm in the Board of Selectmen Meeting Room at Hudson Town Hall, 12 School Street Hudson, NH. Donna Staffier-Sommers provided secretarial duties.

1. Acceptance of minutes

The minutes of the March 21, 2023 Municipal Utility Committee meeting were reviewed with no comment.

Motion made by Bill Abbott; second by Dan O'Brien to "accept the meeting minutes for meeting dated March 21, 2023, as written." Motion carried.

2. Financial Status - Water Utility

Karl inquired as to who or what the Town uses for resources of water compliance. The Committee recommended that he speak to Elvis. In addition, the Whitewater monthly report may provide the information he seeks.

3. Old Business- Water Utility

Water policy review:

Bill Abbott - Town Code Chapter 142 – Municipal Utility Committee, needs updating.

After some discussion, the Committee recommends both the Water & Sewer Policies to reference Town Code Chapter 142-3 regarding Committee membership and to be updated as follows:

The MUC consists of five full members:

- a. Four of whom reside in Town and who reside at dwellings either serviced by the sewer or water system or within sewer districts established by the Town, or own real estate, which is serviced by the sewer or water system or is situated in a sewer district.
- b. One of whom resides in Town and may reside in a dwelling or an area not serviced by water or sewer.
- c. A Selectman may be appointed as liaison but not as a voting member.
- d. The MUC may also have an alternate member who shall meet the qualifications described above.

7. New Business - Sewer Utility

A. Abatement – S-CAP-23-01 Tate 14 Howard Dr. m/l 160-105 #5897

The applicant requests abatement and refund of a sewer capital assessment fee of \$1059.00 paid in 2020. The property did not connect to the sewer system and instead installed a private septic system.

Motion made by David Leary; second by Dawn Lavacchia "to recommend the Board of Selectmen approve abatement S-CAP-23-01 in the amount of \$1059.00 for the reason given." Motion carried.

8. Informational

David Shaw was reappointed to the Committee by the Board of Selectmen on 4/11/23 with term to expire 4/30/2026.
