

The monthly meeting of the Town of Hudson Municipal Utility Committee was held Tuesday, May 16, 2023 at 7:00pm in the Board of Selectmen Meeting Room at Hudson Town Hall, 12 School Street Hudson, NH. Donna Staffier-Sommers provided secretarial duties.

1. Elections

The Committee had elections.
