VI. NEW BUSINESS

A. Vital Delivery Solutions

21 West Road SP# 02-23 Map 101/Lot 004 Purpose: to change use of existing site from machine shop to warehouse. Application acceptance & public hearing.

Mr. Etienne moved to accept the site plan application for the Vital Delivery Solutions Site Plan SP# 02-23, 21 West Road, Map 101/Lot 004.

Motion seconded by Mr. Ulery. All in favor -motion carried 7/0/0.

Karl Dubay, Dubay Group, presented the project with applicant Matt Koszlowski.

Mr. Crowley moved to approve the site plan application for the Site Plan / Vital Delivery Solutions, LLC, Map 101 Lot 004, 21 West Road, Hudson, New Hampshire; prepared by: The Dubay Group, Inc. 136 Harvey Road, Bldg. 101B, Londonderry, NH 03053; prepared for: Vital Delivery Solutions LLC, 57 Harvey Road, Londonderry, NH 03053; consisting of 3 sheets including a cover sheet and general notes 1-9 on Sheet 3; dated March 15, 2023; last revised, March 20, 2023; subject to, and revised per, the following stipulations:

- 1. All stipulations of approval shall be incorporated into the Notice of Decision, which shall be recorded at the HCRD, together with the Plan.
- 2. Prior to the Planning Board endorsement of the Plan, it shall be subject to final administrative review by Town Planner and Town Engineer.
- 3. Hours of refuse removal shall be exclusive to the hours between 7:00 A.M. and 7:00 P.M., Monday through Friday only.

Mr. Ulery made a motion to continue the public hearing on the Historic Resources Chapter of the Master Plan to April 26, 2023.

Motion seconded by Mr. Crowley. All in favor – motion carried 7/0/0.

B. Workshop – Community Facilities Chapter of Master Plan.

Mr. Etienne made a motion to schedule a public meeting on the Community Facilities Chapter of the Master Plan to April 26, 2023.

Motion seconded by Mr. Ulery. All in favor – motion carried 7/0/0.

C. Zoning Ordinance Review Committee

The Board discussed the need for a joint zoning & planning board subcommittee to review the zoning ordinance for potential improvements. Recommendation was Two (2) Zoning Board Members, three (3) Planning Board Members, and one (1) Selectman. Mr. Malley, Mr. Oates, and Mr. Etienne, all volunteered from the Planning Board.

D. Planning Board Bylaws Discussion

The board discussed the bylaw changes specific to filling vacated seats, and what the procedures to fill them are.

Mr. Etienne moved to table the discussion on the Planning Board Bylaws, on the topic of vacancies, to the May 24, 2023 Planning Board meeting.

Motion seconded by Mr. Ulery. All in favor – motion carried 7/0/0.

Mr. Crowley moved to schedule a workshop for the Planning Board Bylaws on June 14, 2023.

Motion seconded by Mr. Etienne. All in favor – motion carried 7/0/0.

E. Election of Planning Board Officers

Mr. Ulery moved to nominate Mr. Malley as Chairman. Motion seconded by Mr. Etienne. All in favor – motion carried 7/0/0.

Mr. Crowley moved to nominate Mr. Oates as Vice-Chairman. Motion seconded by Mr. Oates. Motion failed 2/5/0 (Ulery, Etienne, Lawlor, Guessferd, Malley opposed)

Mr. Ulery moved to nominate himself, Mr. Ulery, as Vice-Chairman. Motion seconded by Mr. Etienne. Motion carried 5/2/0 (Oates & Crowley opposed).

Mr. Crowley moved to nominate Mr. Etienne as Secretary. Motion seconded by Mr. Guessferd. Motion carried 6/1/0 (Oates).

VIII. ADJOURNMENT

Mr. Crowley moved to adjourn. Motion seconded by Mr. Lawlor. Motion carried 7/0/0. Meeting adjourned at 9:01 P.M.
