- **Question 3:** Do you believe there is a need for expansion or additional facilities to accommodate the growing demand and potential future growth of the youth recreation programming? If so, please explain and specify the desired features or amenities to be included.

- **Question 4:** In your opinion, is Lions Avenue the most suitable location for present and future youth recreation programs, or would you like to suggest other locations for exploration?
- **Question 5:** Do the different programming entities in our town have regular communication and collaboration with each other? If not, how do you think improved communication and coordination between these entities could enhance the overall programming and services offered to our community?
