23-27 Library Street Map 182/Lot 129

Purpose: to depict the subdivision of Map 182/Lot 129 into two (2) lots. No physical change to the property proposed. Application acceptance & hearing.

TO ACCEPT:

Mr. Crowley moved to accept the subdivision application for Subdivision Plan SB# 05-25, Map 182/Lot 129, 23-27 Library Street, Hudson, New Hampshire.

Motion seconded by Mr. Ulery. All in favor – motion carried 7/0/0.

Wichert LLS, Inc. 802 Amherst Street, Manchester, NH 03104; prepared for: Roman Catholic Bishop of Manchester, 153 Ash Street, Manchester, NH 03104; consisting of 1 sheets and general notes 1-8 on Sheet S1; dated November 5, 2024, revised August 18, 2025; and:

That the Planning Board finds that this application complies with the Zoning Ordinances, and with the Land Use Regulations; and for the reasons set forth in the written submissions, together with the testimony and factual representations made by the applicant during the public hearing;

Subject to, and revised per, the following stipulations:

- 1. The Planning Board approved the Subdivision Plan entitled: All stipulations of approval shall be incorporated into the Notice of Decision, which shall be recorded at the Hillsborough County Registry of Deeds (HCRD), together with the Plan.
- 2. Prior to the Planning Board endorsement of the Plan, it shall be subject to final administrative review by the Town Planner and Town Engineer.
- 3. All monumentation shall be set or bonded for prior to the Planning Board endorsing the Plan-of-Record.
- 4. Easement language for the parking areas and walkways shall be favorably reviewed by Town Counsel and the Town Planner, prior to recording.

Motion seconded by Mr. Crowley. All in favor – motion carried 7/0/0.
