Conceptual Improvement Plan for Lowell Road (Rte. 3A)

Staff Report February 12, 2014

The attached Conceptual Plans (sheets 1 & 2) show the planned improvements for Lowell Rd. (Rte. 3A), between Wason Rd. and Hardy Ln. Please note, contrary to swirling rumors these plans do not include a roundabout. Rather, the proposed improvements shown on the Conceptual Plans call for the installation of a new 4-way signalized intersection on Lowell Road (Route 3A), a full access/egress driveway for the Fairview Healthcare Center (already approved by the Town), and other lane improvements south of the proposed signalized intersection. As you can see on Sheet 1 of the Conceptual Plans, the proposed location for the signalized intersection straddles the north part of Haffner's Service Station lot and the south part of the vacant lot now owned by Fairview Healthcare Center.

For Wednesday night's meeting, and because the road improvements are called for within an existing public right-of-way, the applicant is presenting the subject plans to the Planning Board, relative to possibly securing a favorable recommendation from board to the Board of Selectmen. Again, because the improvements involve a public right-of-way, any improvements thereto require BOS approval, with input provided by the Planning Board.

At the meeting the applicant will answer any questions the board may have concerning this proposed improvement project, i.e., how it will be funded and will the applicant be seeking to use the \$34,000 still held by the Town, via the Stop & Shop Site Plan Approval. As board members will recall, last fall the specifics regarding these funds were reviewed by the board, with the BOS deciding not to allow the expenditure of these funds for study and design purposes, but rather, for costs associated with the actual construction of the improvements.

In addition to the above, the applicants, who at the meeting will be represented by Tony Basso, will also be prepared to answer any questions concerning future plans to expand the Market Basket property and development plans for the remaining vacant parcel between Haffner's Service Station and the Fairview site. This latter site, as board members will recall, is owned by Fairview Healthcare Center. Also for the meeting, Tony Basso will present the Design Justification Report for the proposed road improvements.

If the above presentation progresses to the point where a MOTION is required, i.e., relative to forwarding a recommendation to the BOS, staff prepared same below for the board's consideration.

Request to Release School Impact Fees

In accordance with the attached memorandum from Karen Burnell, Business Administrator for the Hudson School District, the below DRAFT MOTION is provided for the board's consideration.
