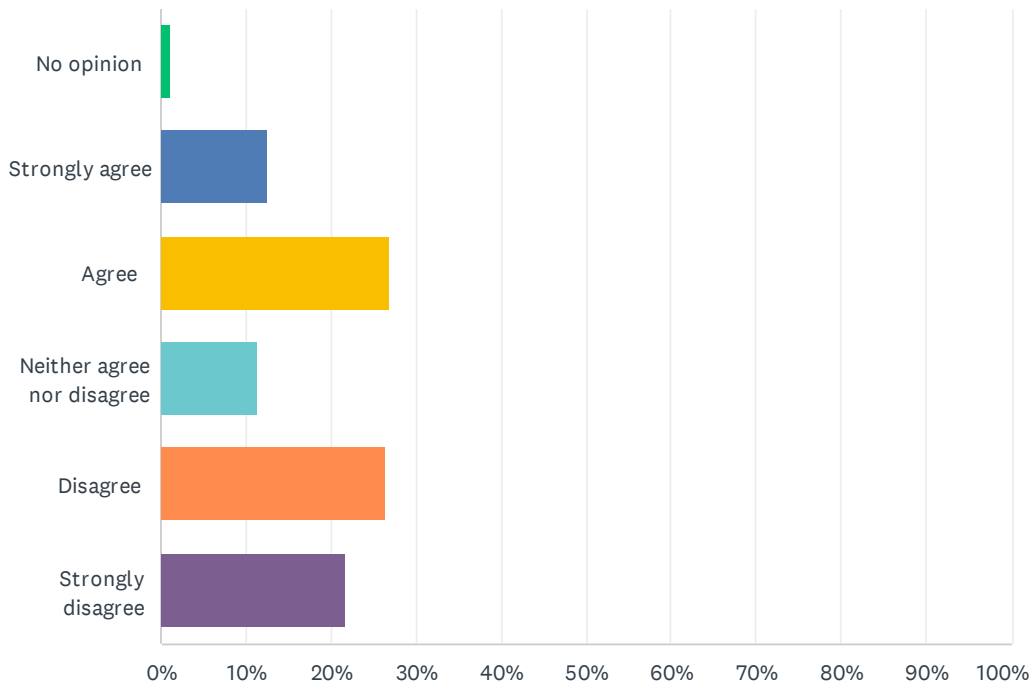

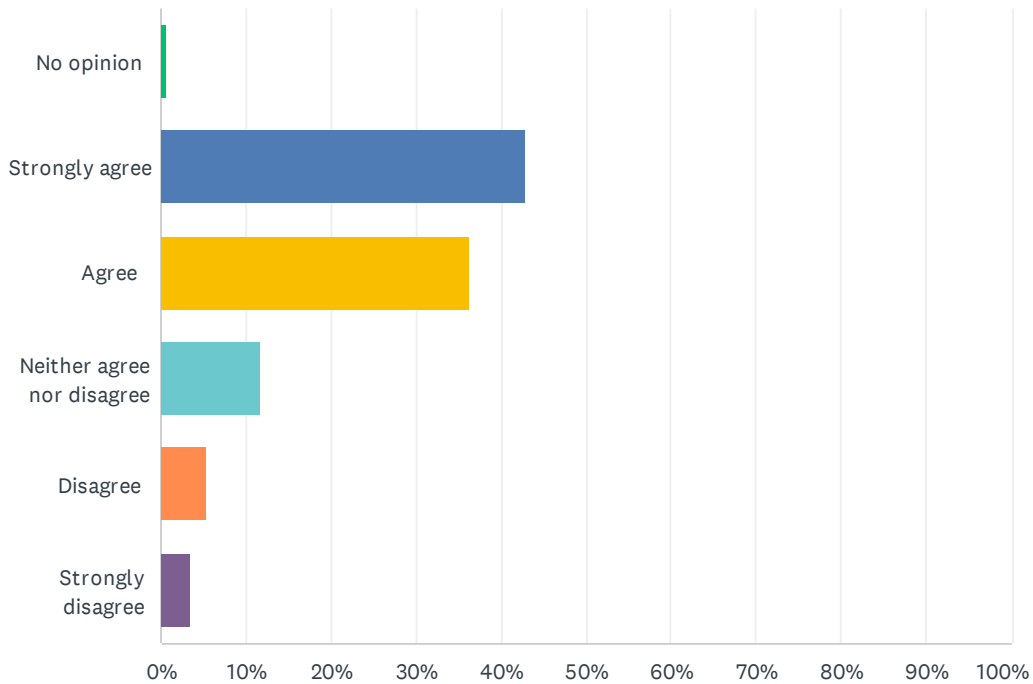

Q2 Please indicate your level of agreement or disagreement with the following statement: "Hudson should strive to expand Conservation areas and increase open space."

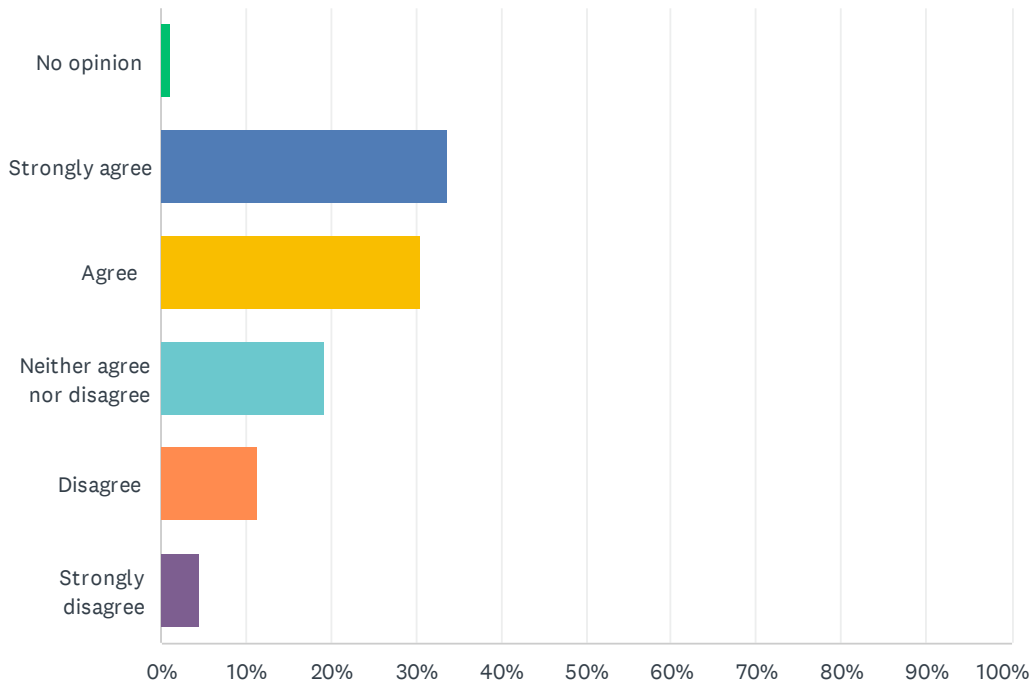

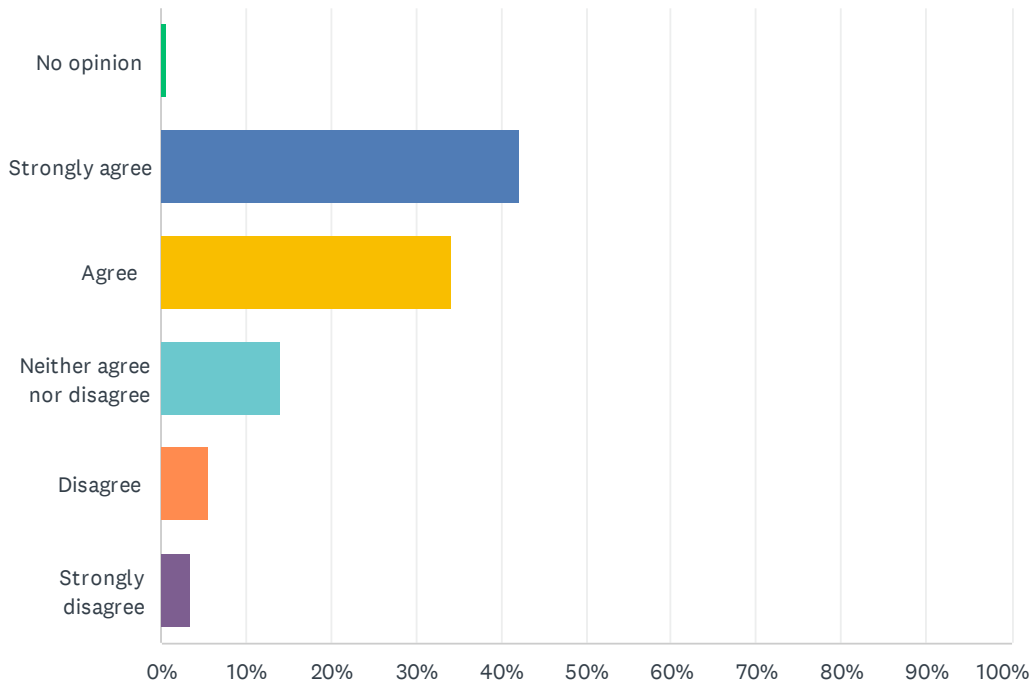

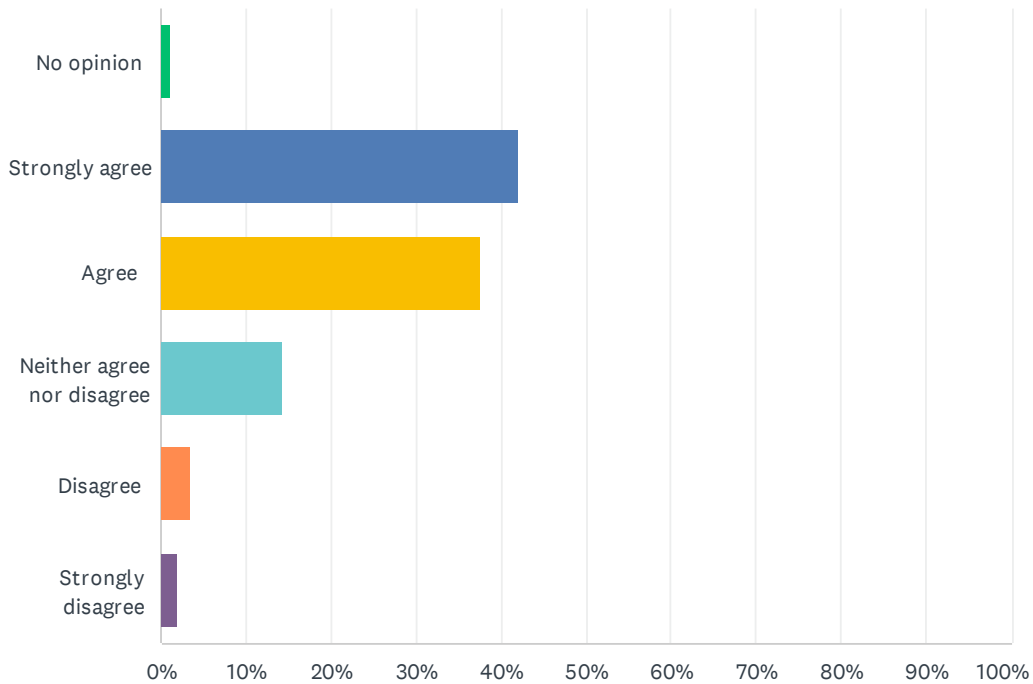

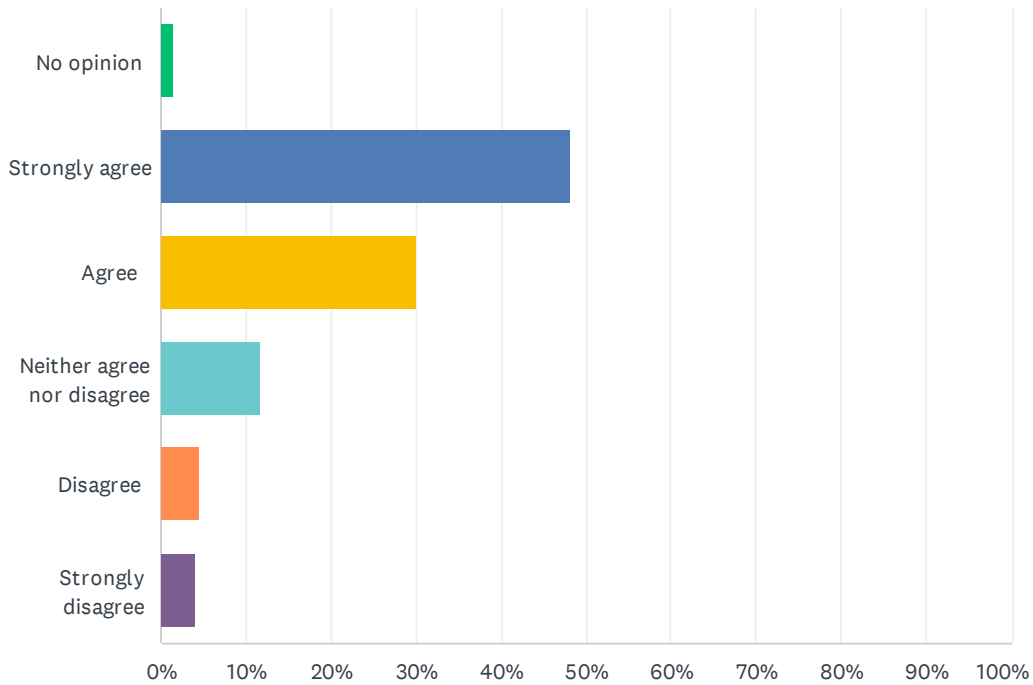

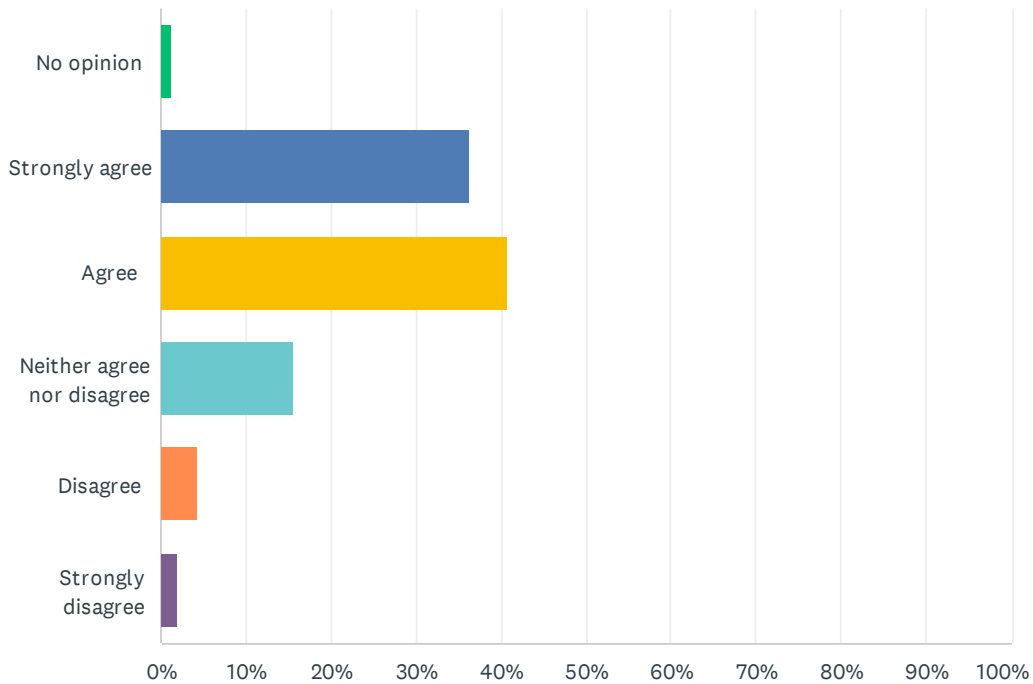

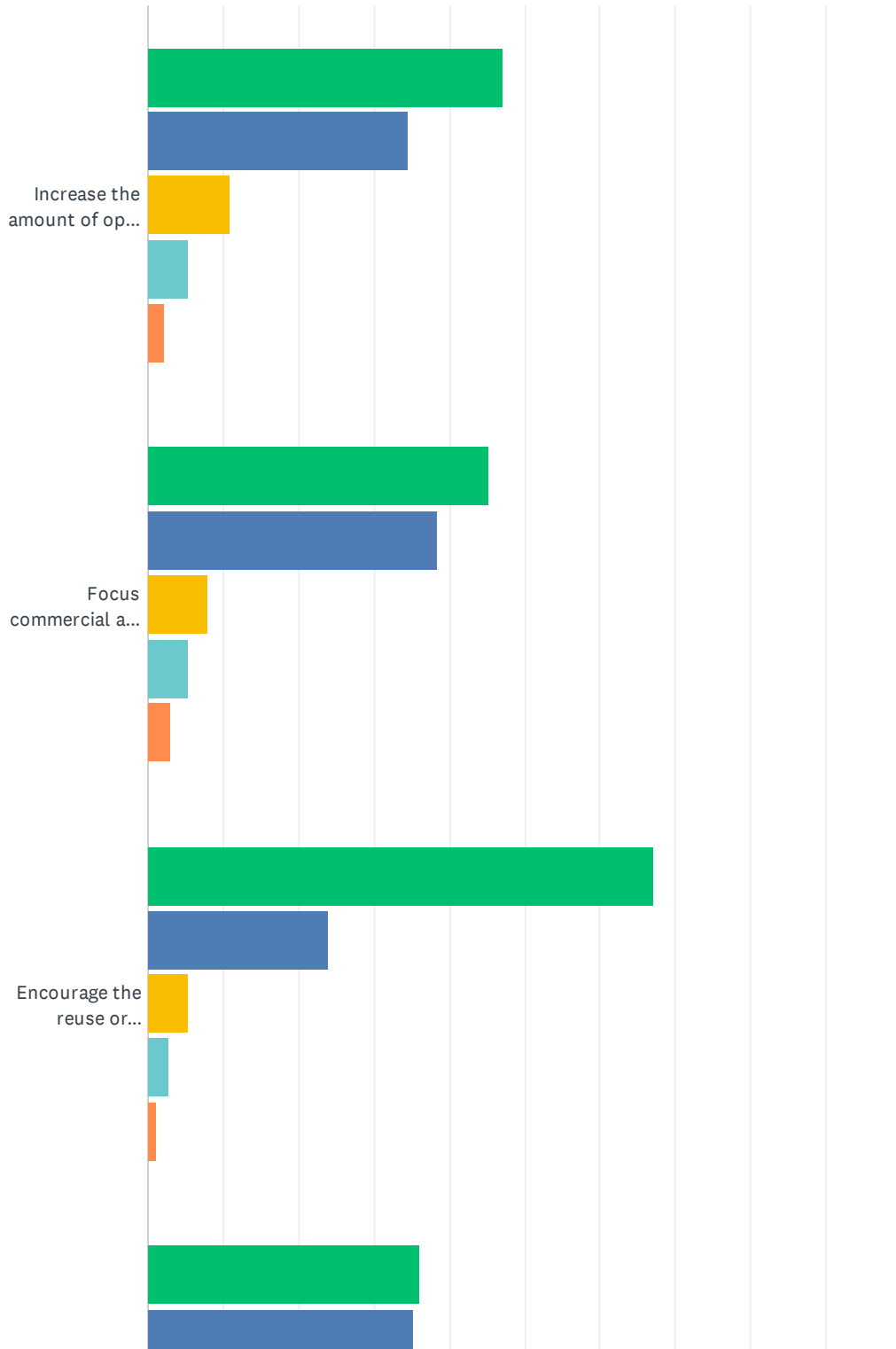

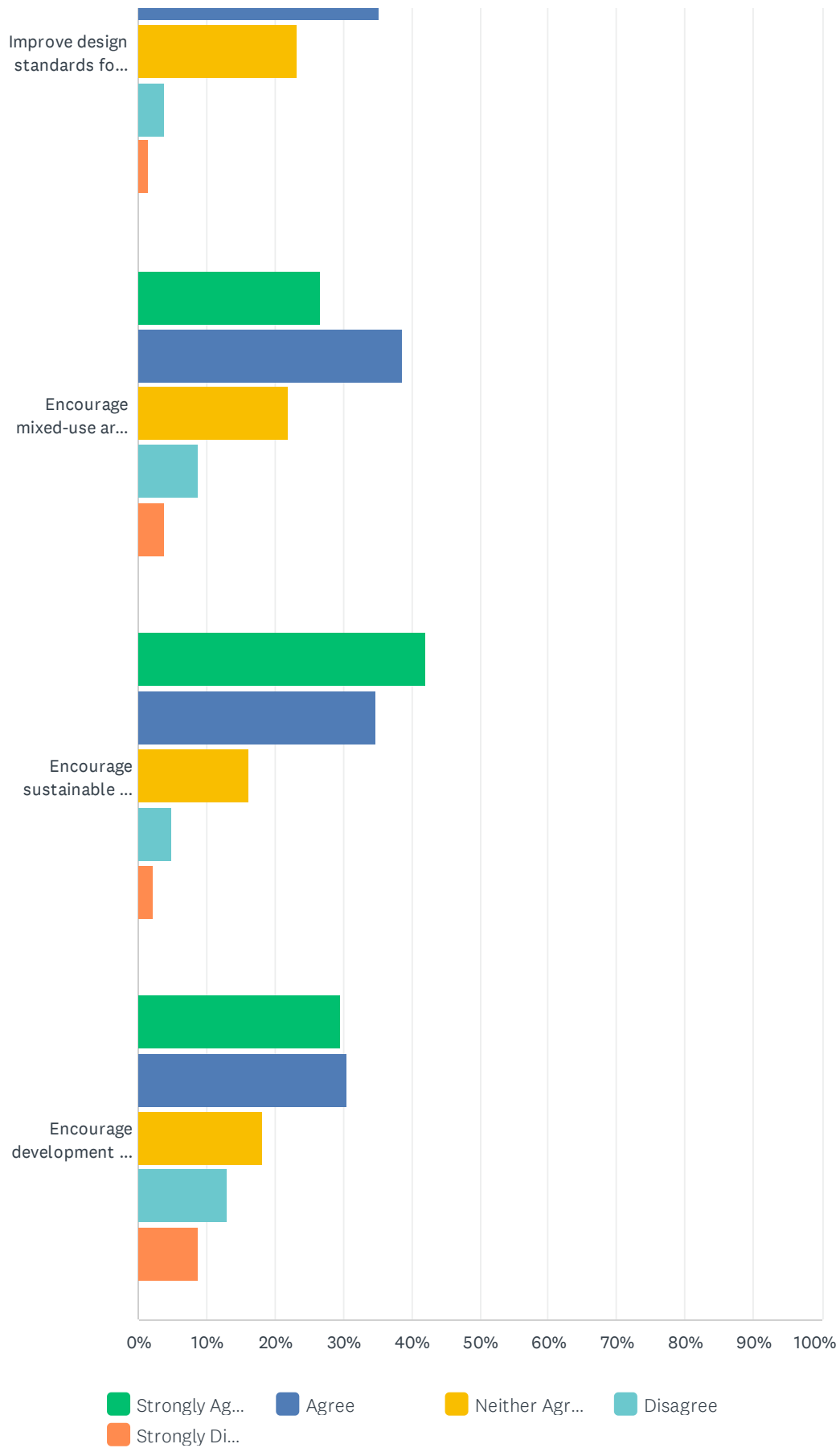

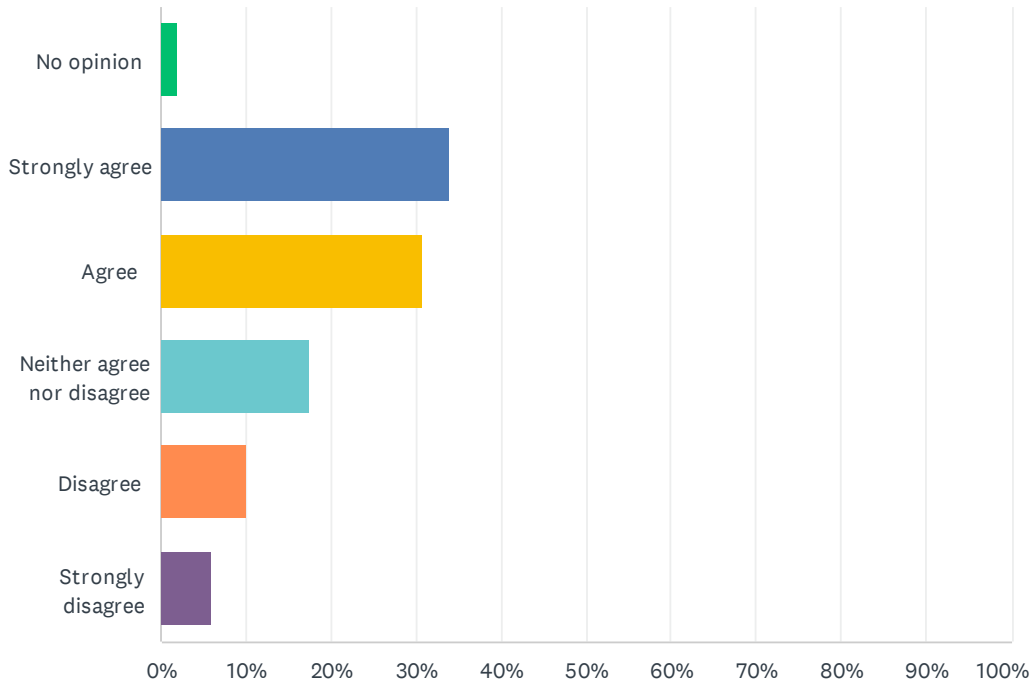

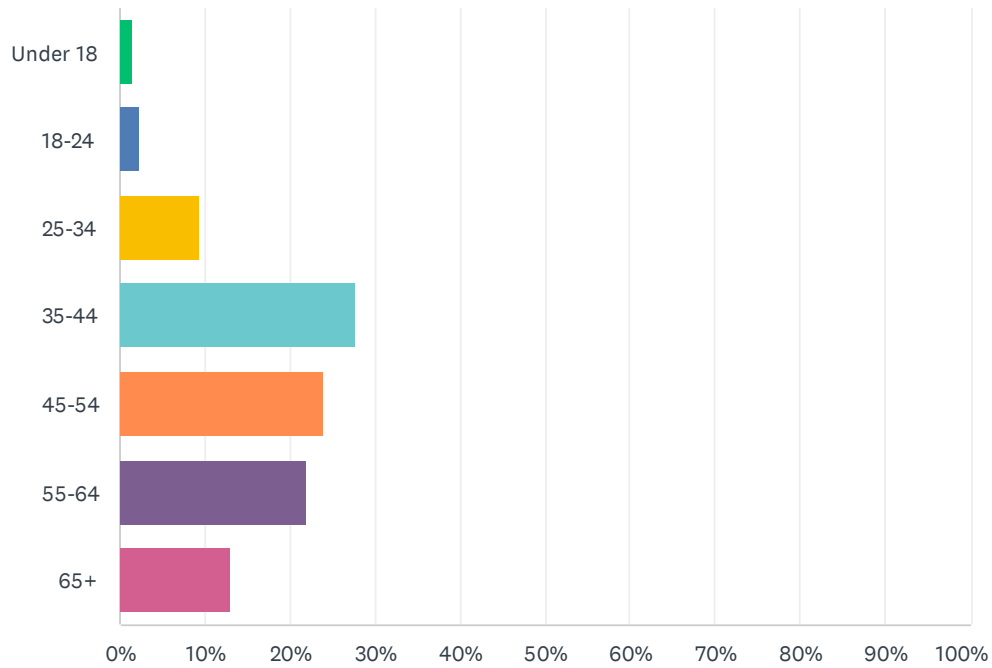

Q14 What is your age?

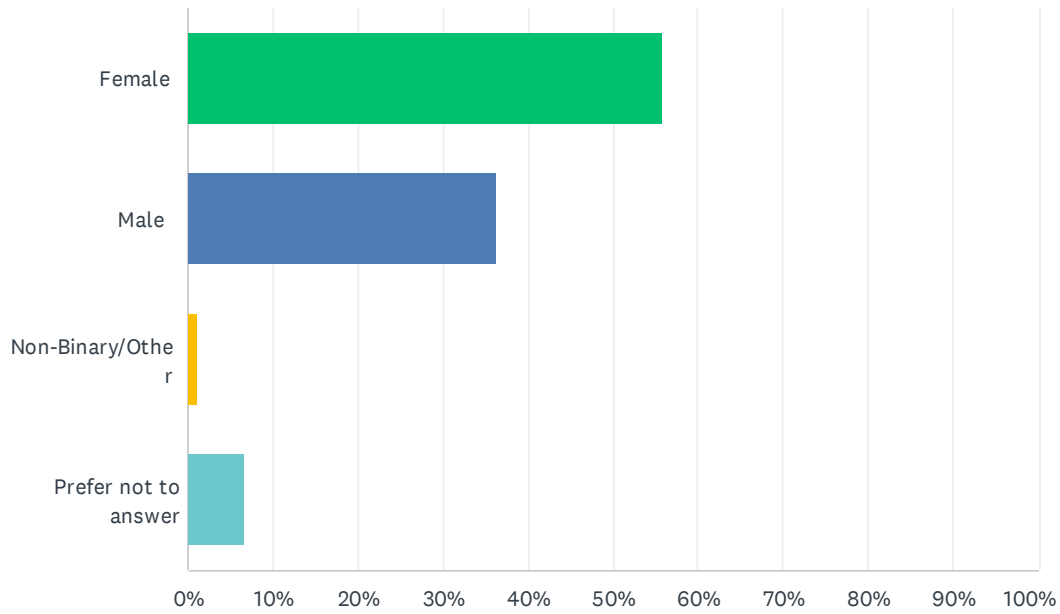
