I want to acknowledge my appreciation of your previous beneficial review comments. I didn't expect you would have all packet materials on the website yet. Please discuss it with Chairman Malley. Also the Town Attorney if you think it necessary.

I hope the letter doesn't violate RSAs, Case Law or Planning Board Member protocols or any arguments that it should not be published.

Hopefully, it gives clarification that only Chapter VII - Historic Resources and Chapter VIII - Community Resources will be open to public input March 22, 2023 and NO other topics. I think if this is not mentioned or clearly explained early as possible the public will end up frustrated when they do arrive to talk about everything. Also my goal is to explain why the public should take a strong interest in what visions and goals are included in the Master Plan.

When I read the written responses in the Master Plan survey comments I saw several negative comments about the Planning Board not addressing and resolving many problems that exist in Hudson. The public may want quick implementation of all-encompassing regulations and Zoning Ordinance to implement their visions. During Master Plan meetings attended by the public they can be educated by the Planning Board about the process of creating and codifying land use regulation and Zoning Ordinance related to it. Can't say it will remove all negative feelings but the public relations and education when the Planning Board is given an opportunity to do so should be done. This will help explain why well vetted regulation and ordinance takes time and not always completed in the past.

Just trying to make the Master Plan communication process work better for Hudson. It appears vetting of realistic near term regulation and arriving at a consensus of long term solutions will have to be and should be repeatedly reiterated.
