

**BELKNAP ROAD EXT. RIGHT-OF-WAY**  
**REQUEST FOR CORRIDOR FUND**  
**MODIFICATION**  
FROM DEVELOPMENT SERVICES DEPARTMENT  
**STAFF REPORT**  
January 14, 2026

**PURPOSE:** The Town has completed the third-party property valuations for the required right-of-way, permanent easements, and temporary easements at 76 and 78 Lowell Road related to the Belknap Road Extension, with a combined estimated value of \$210,000. In August 2025, the Planning Board recommended to the Board of Selectman and expenditure amount of \$200,000 for this purpose. To date, \$47,500 has been expended for the property valuations and related professional services. This request is to modify the original recommended expenditure amount of \$200,000, to an amount not to exceed \$260,000.

RE: Lowell / Birch / Belknap Road – Update and Request for Funding



In 2019, the Planning Board initiated an assessment and evaluation of potential improvements to Lowell Road and County Road. That effort resulted in multiple improvement scenarios, including construction of a new road segment connecting Belknap Road to Lowell Road.

The Town is currently working to advance this project by pursuing inclusion in the State Ten-Year Transportation Improvement Plan while also preparing the project to be shovel-ready. This work includes completing design, permitting, and securing the necessary right-of-way.

The Town has completed third-party property valuations for the required right-of-way, permanent easements, and temporary easements at 76 and 88 Lowell Road, with a combined estimated value of \$210,000. In August 2025, the Planning Board recommended to the Board of Selectmen an expenditure of \$200,000 for this purpose. To date, \$47,500 has been expended for property valuations and related professional services.

Staff is now requesting the Planning Board recommend to the Board of Selectmen a modification in the original expenditure amount for the use of corridor funds for the acquisition of right-of-way, in an amount not to exceed \$260,000.
