**Warrant Article 1  
Operating Budget**

Shall the Hudson School District vote to raise and appropriate as an operating budget, not including appropriations by special warrant article and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by the vote at the first session, totaling \$52,534,706? Should this article be defeated, the operating budget will be \$52,366,374 which is the same as last year with certain adjustments required by previous action of the Hudson School District or by law; or the governing body may hold one special meeting under RSA 40:13X and XVI to take up a revised operating budget only.

**Warrant Article 2  
Collective Bargaining Agreement between the Hudson School Board and the Teamsters**

Shall the Hudson School District vote to approve the cost items in the collective bargaining agreement between the Teamsters Local No. 633 of NH for the Hudson School District Custodians, Electricians, HVAC Technicians and Maintenance staff and the Hudson School Board, which calls for the following increases in salaries and benefits at the current staffing levels over the amount paid in the prior fiscal year:

2017-18	\$20,877
2018-19	\$ 9,471
2019-20	\$36,872

and to further raise and appropriate \$20,877 for the upcoming fiscal year, such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement that would be paid under current staffing levels.

Shall the Hudson School District vote to approve the cost items included in the collective bargaining agreement between the AFSCME Local 1906, School Administrators, and the Hudson School Board which calls for the following increases in salaries and benefits at the current staffing levels over the amount paid in the prior fiscal year:
