The plan was to cut a check to the Town in May for all of these expense items prior to fiscal year end, these items are: to discontinue 6 older capital reserve funds (voter approved) at \$80,986.89 the funds will go back into Town reserves (funds to close are: Cable Access Ctr. CRF, Future Senior Ctr. CRF, Library Expansion CRF, Lowell/River Road CRF, Merrifield Park Pond CRF, Merrimack River Board Ramp CRF); also reduce: Recreation Equipment CRF at \$19,875 (Greeley Park lighting); Major Repairs to Town Buildings CRF at \$74,528 (Community Ctr. replacement floor); Information Services CRF at \$69,425 (fiber optic upgrade); Recreation Fields CRF (Freedom Field II) \$228,029.50 – this account will be at a zero balance.

b. Investment Policy updated to include what defines a Capital asset. "Capital assets are defined by the Town as assets with an initial individual cost of \$5,000 or more and an estimated life in excess of one year."

Motion by Trustee Lathrop to approve the Town of Hudson, NH Investment Policy for the Trustees of Trust Funds as amended Revision #11 to include reimbursement of an asset with a minimum of \$5,000 under section 7 Other Constraints dated 5/24/18, 2<sup>nd</sup> by Trustee Duchesne, carried 3-0.

  - a. Recreation Scholarship Trust requests for payouts to recipients: Jeffrey Piantaggini, (check #144), and Christos Tufts (check #145) both scholarships in the amount of \$500.00, checks released to Dave Yates once funds transfer.
