#### **Acceptance of Minutes**

#### 6. OLD BUSINESS

A. Update/amend Investment Policy – reviewed by Harry with recommended edits. Prepare for signature with recommended edits at the next meeting.

Motion by Trustee Lathrop to approve Investment Policy with edits as discussed, carried 3-0.

- B. Process payment of previously approved requests from the Town and other final F/Y17 Town requests from Capital Reserve Funds of \$185,521.71 (check #139) from: Major Repairs to Buildings of \$53,329.71, Police Weapons of \$61,671.00, Property Revaluation of \$32,987.00, Fire Equipment of \$37,534.00
- C. Recreation Scholarship Trust Fund two \$500.00 scholarship checks were awarded at the June 12<sup>th</sup> Scholarship night to N. Bellomo (check #137) & H. Mousseau (check #138). A deposit to the Trust was previously processed in February in the amount of \$1002.00. These funds are raised at various raffles during Comedy nights put on by the Town.
- D. Closing of six older Capital Reserve funds as a result of town meeting vote in March 2017 will take place in F/Y18 for accounting purposes. Procedures to close-out accounts will be reviewed at our next scheduled meeting.
