5. <u>PRESENTATIONS:</u> People's United Wealth Investment Advisors, Chris Lucas and Mark Cross-Powers presented the latest quarterly update on our current portfolios. We had a good first quarter, January – March 2017. There are several current international and domestic issues that are driving investment decisions. We discussed reducing the percentage of cash being held in both the Capital Reserves and Trusts. There is an expectation this month (April) of a payout of \$150,000 (School) from Cap. Res. and \$1,000 from Trust (Rec. Schol.). In June the expectation of payout is approx. \$125,000 from Cap. Res. (Major Building Repairs, Police Weapons, Prop. Reval., Fire Equip.).
