# **MINUTES OF THE August 29, 2013 MEETING**

1. <u>CALL TO ORDER</u> – by Trustee Duchesne the meeting of August 29, 2013 at 2:33 p.m. In the Buxton Community Development Meeting Room at Town Hall.

## 2. <u>ATTENDANCE</u>

<u>Trustees of Trust Funds</u>: Ed Duchesne, Harry Schibanoff (Trustee Lathrop was unable to attend)

**<u>Staff/Others</u>:** Kathy Carpentier, Finance Director; Paula DeAngelis, Clerk to Trustees and Warren Mackensen of Mackensen & Co., Inc.

3. PUBLIC INPUT

The meeting was opened to Warren Mackensen. He reviewed/explained year-end FY13 documents including his performance review and July 2013 statements. Warren explained that the market fell in both May and June. A discussion was held regarding Paula sending Warren a Mackensen form "Request for Distribution" or "Deposit Notice" whenever funds are sent or requested from Mackensen in order to distinguish principle vs. income or fiscal year. It was decided that Paula would fill-out and send form; however Mackensen & Co. would not act on it until funds were actually sent via ACH or by other means as Paula has no banking authority.
