MINUTES OF THE May 16, 2019 MEETING

1. <u>CALL TO ORDER</u> – by Trustee Lathrop the meeting of May 16, 2019 @ 3:00 PM., in the Buxton Meeting Room at the Town Hall.

2. ATTENDANCE

3. **PUBLIC INPUT:** None at this time

4. PRESENTATIONS: None at this time

5. **CONSENT ITEMS**

a. Acceptance of Minutes: Minutes of February 28, 2019

<u>Motion by Trustee Schibanoff, seconded by Trustee Duchesne to accept the consent items, carried 3-0.</u>

6. OLD BUSINESS:

a. Pay to the Town \$13,151.94 from Police Vest CRF, previously approved by Trustees at 10/25/18 meeting for 5/18 & 8/18 expenses – combined with 7b. below. Ed asked why these types of expenses aren't coming from the Police operating budget. KC stated that there were warrant articles that used to fund this account, but it is unclear if there will be future funding for this fund.

7. **NEW BUSINESS**:

- a. Recreation Scholarship Trust Three \$500.00 Scholarships being given 6/2019 due to collection/donations of \$1,600+ this year. Recipients this year are: A. Cahill, S. Yi & R. Weston.
- b. Request to payout \$5,320.00 from Police Vest CRF new request 3/19, combined with 6a. above = \$18,471.94.



Motion by Trustee Duchesne to approve pay-outs of three Recreation Scholarships of \$500.00 each and to reimburse Town \$18,471.94 from Police Vest CRF, seconded by Trustee Schibanoff, carried 3-0.

- c. New Town Web Page Trustees of Trust Funds. KC gave a brief tutorial showing where the Trustee site is on Web page. The current list of Capital Reserves and Trust Funds were asked to be updated.
- d. Westview Cemetery Board of Directors met with Len to discuss possibly getting reimbursed \$2,655.00 from perpetual care income for mowing expenses from the Westview Cemetery Trust. Also discussed was other investing of funds. The Trustees agreed that because they are a non-town group other types of investments should not go through our investment advisors.
