# **MINUTES OF THE May 20, 2021 MEETING**

1. <u>CALL TO ORDER</u> – by Trustee Duchesne the meeting of May 20, 2021 @ 3:03 PM., in the Buxton Meeting Room at the Town Hall.

- 3. **PUBLIC INPUT:** None at this time.
- 4. PRESENTATIONS: People's United Advisors, Chris Lucas & Wil Flemming- gave a virtual presentation with current trends updating information regarding both The Capital Reserve and Trusts accounts. Copies of their presentation have been emailed to the group. Some of the highlights included: watching the Federal Reserve decisions closely, another possible Stimulus to qualified Americans, Auto manufacturing industry is down, lumber commodities with milling issues driving costs up, oil/gas cost may rise due to production issues, current day-care issues & getting people back into the work force, struggles with food service industry getting their help back, and summer tourism shortage of labor. All of this will certainly impact the economy over time with possible tax hikes and/or inflation. Current rate of return on the Capital Reserve fund: Year-to-date (Jan. April 30, 2021) 5.8%; One Year (April 2020-2021) 23.5%; since inception (7/31/14) 6.7%. Rate of return for the Trust Fund: Year-to-date 5.4%; One Year 25.2%; since inception (8/31/14) 7.09%.
