  - a. Investment Policy completed and signed 6/2021
- 7. **<u>NEW BUSINESS:</u>** 
  - a. Chalifoux Scholarship Trust per the 2021 audit these funds were forwarded to the Trustees of Trust Funds. The amount of \$3,066.57 was deposited on 9/24/21, which was the remainder in the account transferred to Trustees from Jane Payne of the School Dept. Per the will of the Chalifoux's only interest earned shall be awarded from the fund annually.
  - b. New funds from the Town in the amount of \$225,000 per the 3/9/21 town vote were received for deposit. Once deposited funds will be allotted to each sub-account: \$60,000 Vaccon CRF, \$25,000 Fire Apparatus Refurbish CRF, \$15,000 Property Revaluation CRF, \$50,000 Major Repairs to Town Buildings CRF, \$50,000 Police Safety Equipment CRF (new), \$25,000 Hills Memorial Library CRF (new)

a. The Trustees discussed possibly going out to bid for a new investment firm in January as People's Advisors will shortly be owned by M&T bank.
